According to IPU, the percentage of women of developing countries in parliament increased from 11.3% (1995) to 27.2% in 2025. In the corporate context, although only 10% of Fortune 500 CEOs are women. This figure represents a significant increase over past decades. Besides formal politics and business, women are influential in the civil society. They lead the non-government organizations. Women like Greta Thunberg and Nobel

Peace prize laureates have steered the global attention toward critical social issues. Similarly female representation in academia and Judiciary like Marie Curie, Bano Qudsia. Women are now professors, Judges, researchers and public ~~center~~ intellectual contributing to creation and interpretation of knowledge and law. Despite these gains substantial challenges remain. Gender stereotype continue to associate leadership with assertiveness and dominance traits of socially coded as Masculine.
