Feudal and tribal leaders take advantage of illiterate societies and ensure through different tactics which include brutal punishments or meager reward to maintain their hegemony in such societies. Illiterate population devoid of importance of human rights, democratic norms, and law and order become tools of these tribal and feudal leaders. As a result, they face abuse at the hands of these structures and unable to resolve the situation. This shows that lack of education, presence of tribal and feudal structures, and disregard for human and women rights are prominent examples of societal issues that impact maintenance of law and order in modern age.

Secondly, lack of visionary political leadership, lack of constitutional supremacy, and prevalence of polarised politics are prominent instances of political challenges to law and order maintenance in modern age. Political leadership that is devoid of long-term vision for a country effectively impedes the law and order situation in a country. Similarly, when there is absence of constitutional supremacy in a country the law and order maintenance becomes a tiring and difficult task. In various countries, political leadership as well as general population do not consider constitution as a supreme law of the land. As a result, they use various unconstitutional means to fulfill their interest at the cost of national interests. For instance, in India political leadership of Hindutva contradicts the secular nature of the constitution and targets Muslim population through both physical and verbal means. As a result, Muslims are facing ^{brute} violence by these BJP supporters and do not get justice. The absence of law and order is due to the lack of constitutional supremacy as these people know they are immune to law. Moreover, prevalence of polarized politics is another factor that affect the maintenance of law and order in a society. Countries such as the USA, Brazil, and Turkey are also

~~victim of this phenomena. Polarized politics by dividing society into two extremes of political spectrum damages the law and order situation in modern age. Polarized politics initiated by the political leadership slowly moves towards the grass root level establishing its bases among the general public. As a result, political leadership in power tries to follow every technique to marginalize the opposition and support their own political votebank. This allows opposition to opt for solutions outside the political and constitutional framework such as Street politics that further damages law and order in modern age. Dharma politics in Pakistan is a substantial example of the polarized politics and its impacts on law and order situation in the country.
