Last but not least, drug abuse is a growing threat to young generation of Pakistan it is because if more young people will involve in drugs there will be more threat to Pakistan's civilisation and its development. In Pakistan almost 50,000 drug addicts (th) add up each year; the number of drug addicts in the country was increased from 50,000 in 1980 to 8.1 million in 2011. Pakistan has approximately 25 to 44 percent of students reporting alcohol and illicit drug use, and prevalence rates are on the incline. This is the real threat because young generation of Pakistan is involved in useless activity.
