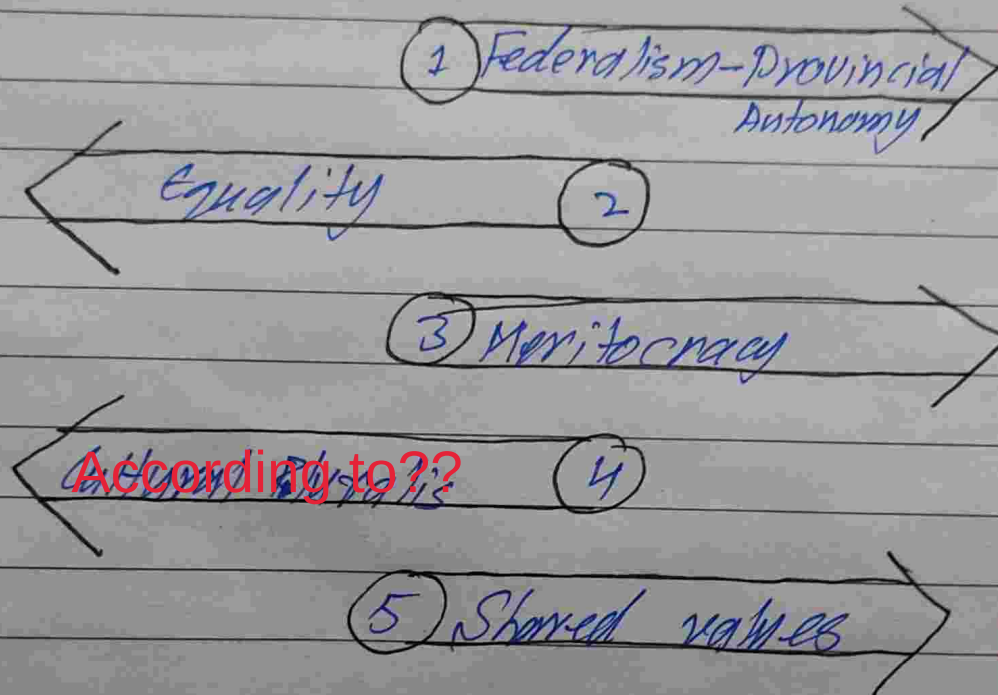

4 Meritocracy and Rule of law:

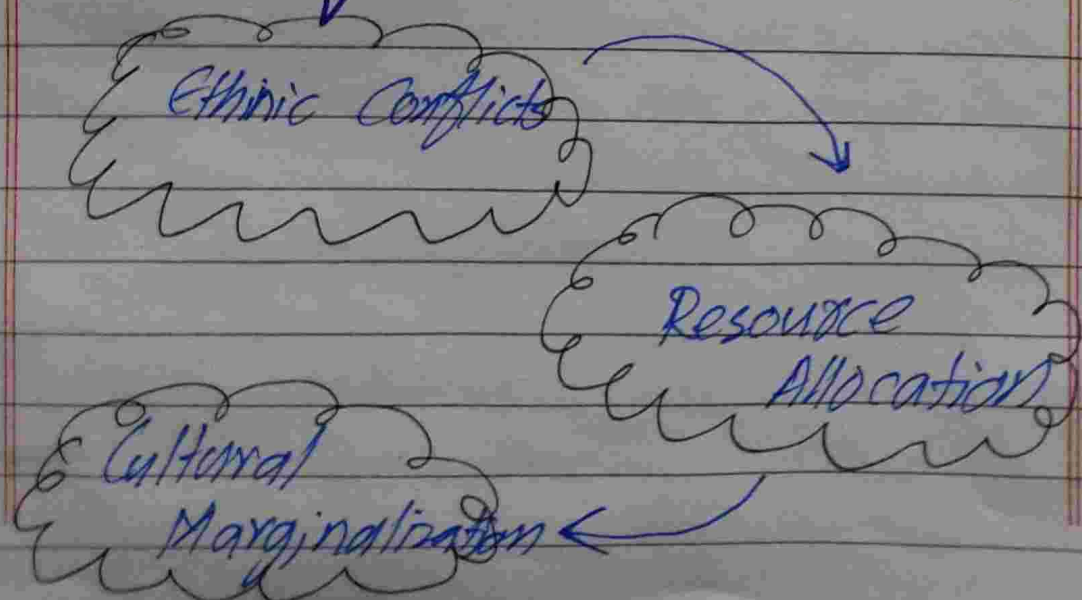
Right person for the right job and equality of all and for all before law.

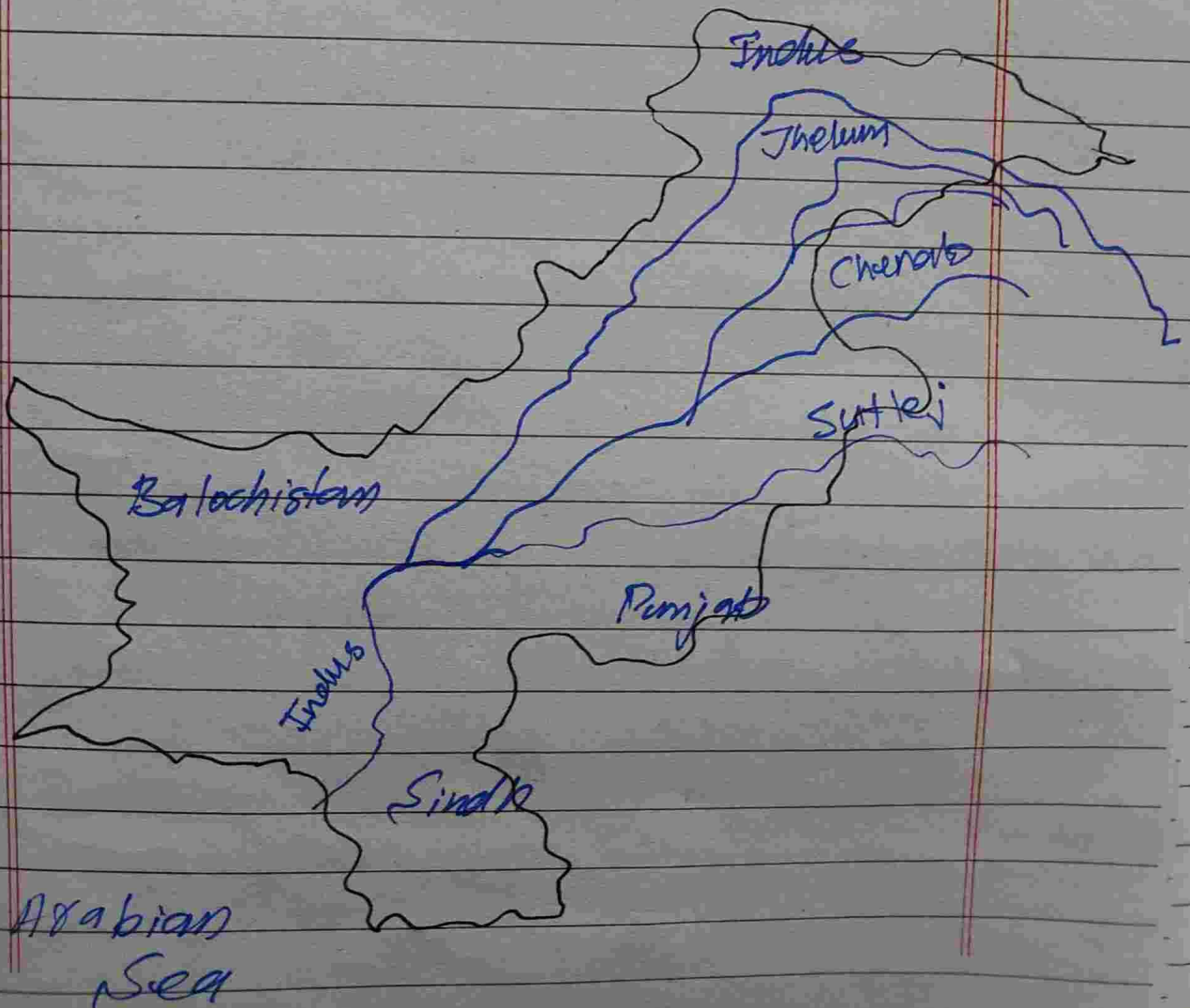

Rivers Shown in Map

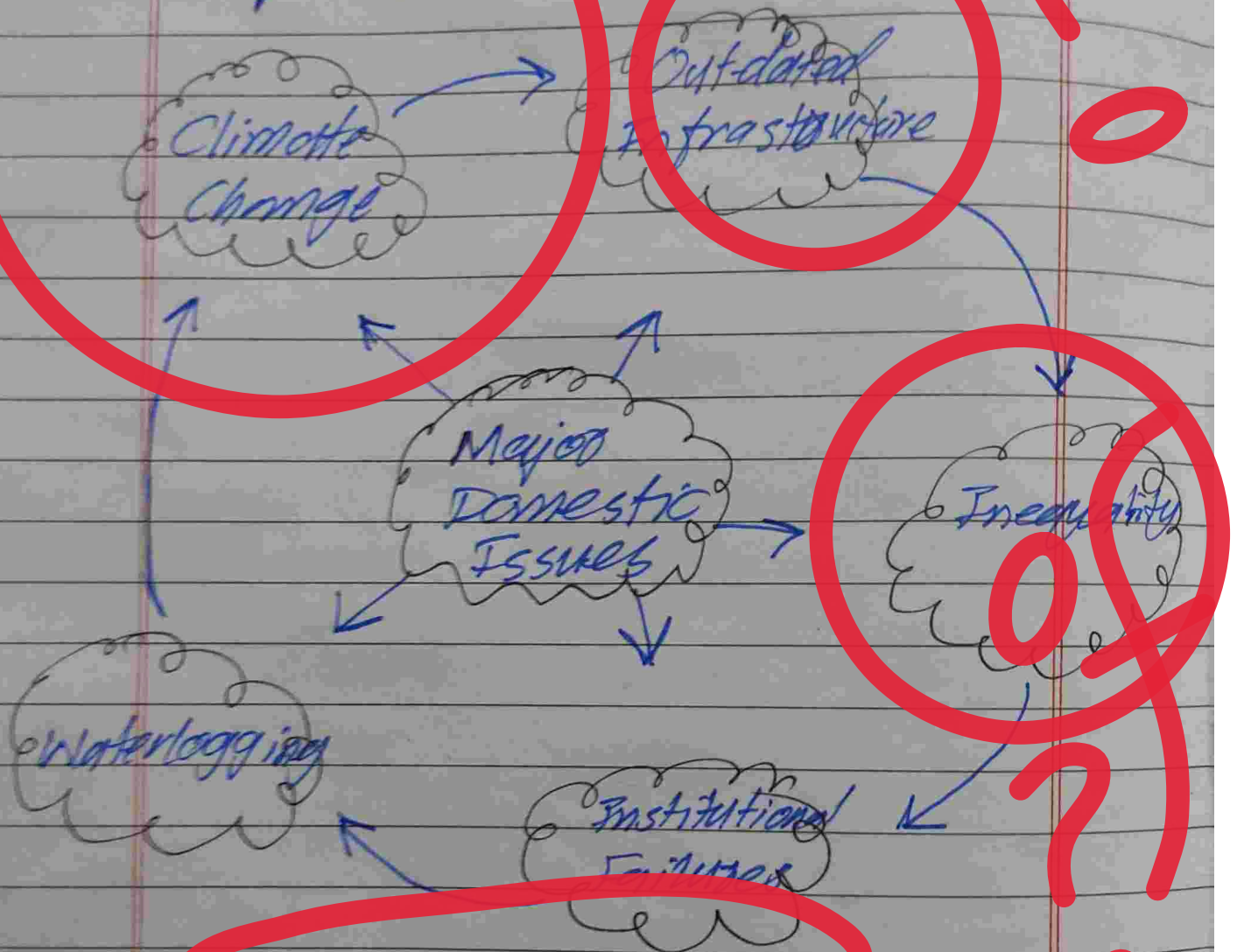

1 Ministry of Water Resources:

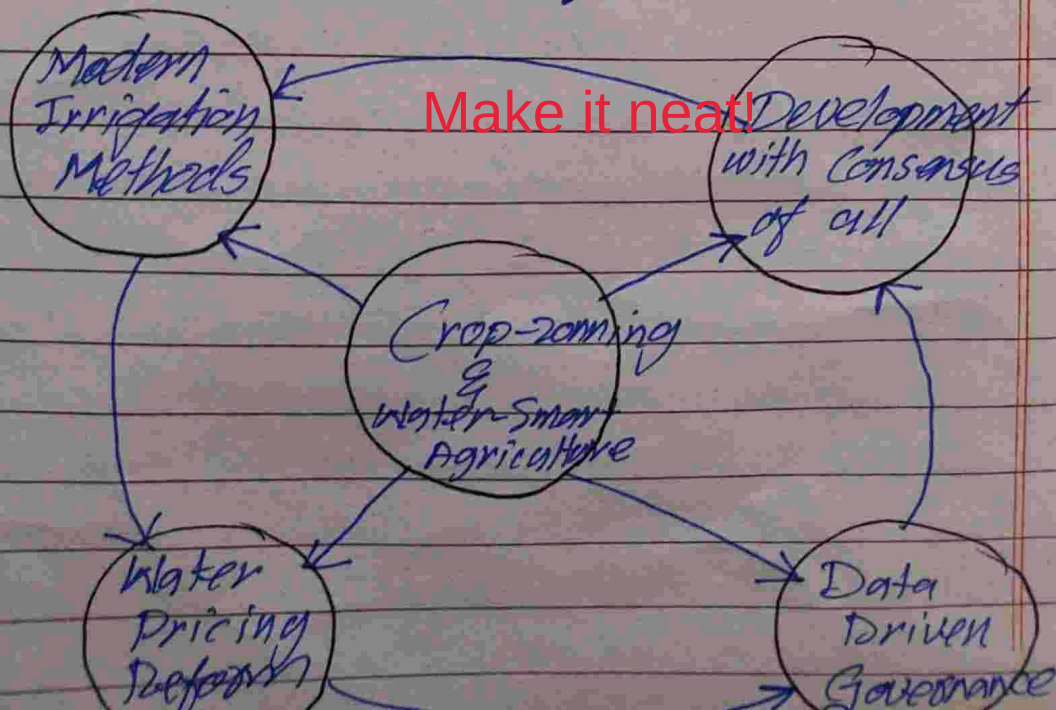
The Ministry of Water Resources develops mainly national water policies. It is a key and an important institute which coordinates and oversees the broader framework of water resource planning.

2 Pakistan Council of Research in Water Resources (PCRWR)

PCRWR conducts research on water conservation, collect data about the new techniques and the efficiency of traditional approaches, etc. It is based on research facts and figures which suggest innovation in planning and irrigation practices.

- 3 Indus River ^{system} Authority:
IRSA is mainly responsible for the fair distribution of water. It mainly provides water of Indus under the 1991, Water Apportionment Accord. It plays a primary role in conflicts resolution.
- 4 Pakistan Water and Power Development Authority (WAPDA):
WAPDA mainly manages construction of dams and canals. It also works for local water distribution management.
