

Q. Indus Water Treaty, 1960:

The Indus Water Treaty was a landmark treaty of bilateral cooperation between Pakistan and India for a fair distribution of river waters which is flowing mainly from India into Pakistan.

major contours of INT

- ① The treaty distributed the river water and divided it into two parts. Three eastern rivers were given to Pakistan (Sutlej, Beas, Ravi), while three western rivers were given to India.

② India will not divert the flow of rivers which belong to Pakistan.

③ Further, India will not make any dam on Pakistan's share of water.

④ It is only allowed to India to make hydroelectricity from the water of Pakistan.

⑤ No party to the treaty ~~can~~ can unilaterally announce the treaty and can only be modified by the consent of both the parties.

⑥ Any contention over the waters between the two countries will

Indus river commission
formed under the treaty
or through the World
Bank under which the
treaty is signed.

② If India intends to built
any dam on the waters
of Pakistan for the
purpose of generating
electricity, the
design, shape and size
of the project should
be shared with Pakistan.

③ Pakistan should be allowed
for the inspection of any time
of any project on those
waters belong to it.

④ India is bound to share
flood and draught alerts
with Pakistan. It has

to inform Pakistan before releasing any waters from dams, so Pakistan would take precautionary measures for any hazard.

Remifification of the treaty in absence for Pakistan

- ① ~~Ind~~ With the absence of the treaty India is relieved from any principle or terms it signed in the Indus Water Treaty, 1960.
- ② Secondly, it will be able to built dams on the waters of Pakistan and blocking its reach.

India was already violating the IWT by making dams such as Bughian and Krishanganga on Pakistan's waters.

③ Third, India will divert the flow of water in its territories creating water scarcity in Pakistan.

④ The absence of treaty will put Pakistan's agriculture in acute danger because 80% of its agriculture depends on these waters.

⑤ Agriculture forms a substantial part of Pakistan's exports. However it will decrease if water were

increase the trade deficit for the country.

⑥ Food insecurity and draught would be another challenge amid the absence of the treaty. Pakistan's agriculture is responsible for the country's own needs which will be endangered. further, the water scarcity has already created a draught conditions which will further worsen.

⑦ 40% of Pakistan's industries depends on these water. They also account for much of the country's exports which will be endangered.

Remunification for India

① A statement by Ex foreign minister, Bilawal Bhutto Zardari aggressively stated to an interviewer, "If water does not flow, the blood of India would". This indicate a tense situation between Two nuclear armed countries pushing the world to the edge of World War Three.

② Pakistan would also drag India to International Court of Justice to show the adversarial face of "Hindutva" India to the whole world which call itself

a democratic state

③ International globalized world stands on mutually stable partnership. The unilaterally sidelining of treaty would compel the world that India is not a reliable partner and not worth of trust. This will shove off India's international standing.

④ India does not have any infrastructure to store or stock such large amount of water. If it does so, it will be catastrophic for India itself in terms of economic cost to built such infrastructure. India will also be effected badly

by floods in times of
unexpected heavy
raining.

The role of Sheikh
Ahmed Sirhindi

Sheikh Ahmed was
born in Sirhind and
is often called Mujaadd
Alf Sani. He was a great
renaissance muslim scholar
of the subcontinent who
stood for the reformation
and revival of muslims.

- ① At that time muslims were
riddled in unislamic
principles and had

developed unislamic believes
contradictory to Islam.
Sheikh Ahmed purged
the muslim society
of such things and
compelled the muslim
to obey the authentic
Islam and sharia.

- ② Sufi's and mystics had
developed magical ways
which were unauthentic.
They also denounced the
sharia and did not referred
to it in their practice
and considered jurispruden-
ce the only source of
guidance. Sheikh Ahmed
denounced these fallacies
and established the
sharia as the main
source of guidance for
muslims.

③ He also negated the concept of wahdatul wajood and introduced the concept of wahdatul shuhud (God and the Created are two different entities)

⑦ He called out Akbar's Din-Ilahi as bid'a and unislamic. He openly negated this alien religion and after the death of Akbar, Jahangir ended this religion.

⑤ He also wrote letters to muslim leaders and scholars to emphasize on the Itikat-e-sunnah.

Shah Wali Ullah and His efforts for muslim revivalism

Shah Wali Ullah was born to Shah Abdur Rahim in Delhi 1703. He was also a great muslim renaissance scholar and reformer. He revived the muslim rule in subcontinent and created unity among muslims.

After the death of Aurangzeb.

- ① Muslims were downfalling. Sikhs and Marathas were gaining foothold. Shah Wali Ullah compelled the muslim chieftains to raise forces against them and wrote letter to Ahmad Shah Abdali who came and

defeated those forces
and restored the inghols
on the throne.

② At that time, there was
great disunity between
muslims pertaining
the Shia and Sunni
controversy. Shah Wali
Ullah presented a
more liberal approach
which created a
unity among the
muslims.

③ Shah Wali Ullah was the
first to translate the
Quran into Persian.
He also wrote around
50 books which were
a great ^{source} for muslim
intellect.

- ④ Shah Waliullah stressed the muslims to practice islam sincerely and established the obligations enjoined upon them by Quah (SWIT) -

Q External causes of the climate change in Pakistan

- Climate change is
- a global phenomenon triggered by carbon emission which causes the depletion and disruption of the

earth's climate - Despite that Pakistan accounts for only 1% of global carbon emission, the country is categorized as the fifth most climate vulnerable country.

Below are the internal factors for Pakistan being climate change worst affected.

① Global Industrialization
