The China's road and Belt Initiative is an illustration that how China is endeavouring for boosting trade and diplomatic relationships. Road and Belt Initiative (BRI) of China connecting Afghanistan, Iran, Pakistan and some African countries. This reveals the China's attitude toward cooperation and parallel world order.

2) Inauguration of initiative such as Asian Development bank for economic security:

China's role in establishing Asian Development bank for securing regional economy also signals about its nature of multilateralism. This bank provides loans for infrastructure development, economic stability and development of market for competition. This reveals China's attitude towards cooperation.

3) Establishment of organization to counterweigh west — SCO, Brics:

4) China's endless efforts for technological development:

4) Counter argument — Limits to China's Reliability Narrative:

a) Transparency Deficit:

There are concerns about opaque BRI contracts and debt traps. This can be visualized by Sri-Lanka's Hambantota port.

b) Assertive Behavior in South China Sea:

China's soft image is being tarnished due to its assertive behavior towards other states in South China Sea. The militarization and aggressive territorial claims undermine China's "peaceful rise".

c) Human rights concerns:

Xinjiang, Hong Kong and cybersecurity laws erode China's soft power globally.

5) Critical evaluation — Emergence of a Fragmented, Hybrid order

Many critics argue that china is not creating a new world order such as parallel world order. While it is modifying the existing order. It adopting parallel nature in some aspects while in actual it is trying to replace US.

Conclusion:

To conclude, it is clearly stated that due to US' non-cooperative behavior, it is facing backlashes. temporarily while in permanent sense, china is not completely moving toward parallel world order, as there are also some limitation present in china's attitude.
