Q2 MILITANCY IN KP & BLN

(I) Introduction

Pakistan overall, but KPK and Balochistan particularly, are in the midst of deep-rooted wave of militancy. The two provinces have had their fair share of terrorism in the past; however, this time there are many compounding factors which are now culminating in an unprecedented rise of terror. These two provinces are at heartland of terror-related incidents. Not As such, holistic policy measures are needed to overcome this growing tide of militancy. The situation within these 2 provinces alone has pushed Pakistan into 2nd place in the Global Terrorism Index.

(II) Causes for the revival of militancy

(A) Rise of the Afghan Taliban

The takeover of Afghanistan by the Afghan Taliban in 2021 has led to ~~test~~ a safe-haven for terrorists. A UN Security Council Report highlights that Afghanistan has become a hub for 23 militant outfits. This blanket sanctuary allows militants to carry out attack, while remaining outside the reach of law.

(B) Construction of the India-Afghanistan Nexus

The BJP government has empowered the Afghan Taliban into supporting the TTP against Pakistan. Repeated claims by the military brass through the use of ISPR have highlighted the rise of the Indo-Afghan nexus. The result of which is an empowered

TTP.

(C) Exploitation of long-standing grievances

Both provinces, but Balochistan in particular, have voiced long-standing grievances against the federal government. The Balochistan Liberation Army preys on these grievances to add more recruits to its cadres. Consequently, these grievances directly contribute to the rise of militancy.

(D) Militants capitalising on economic marginalisation

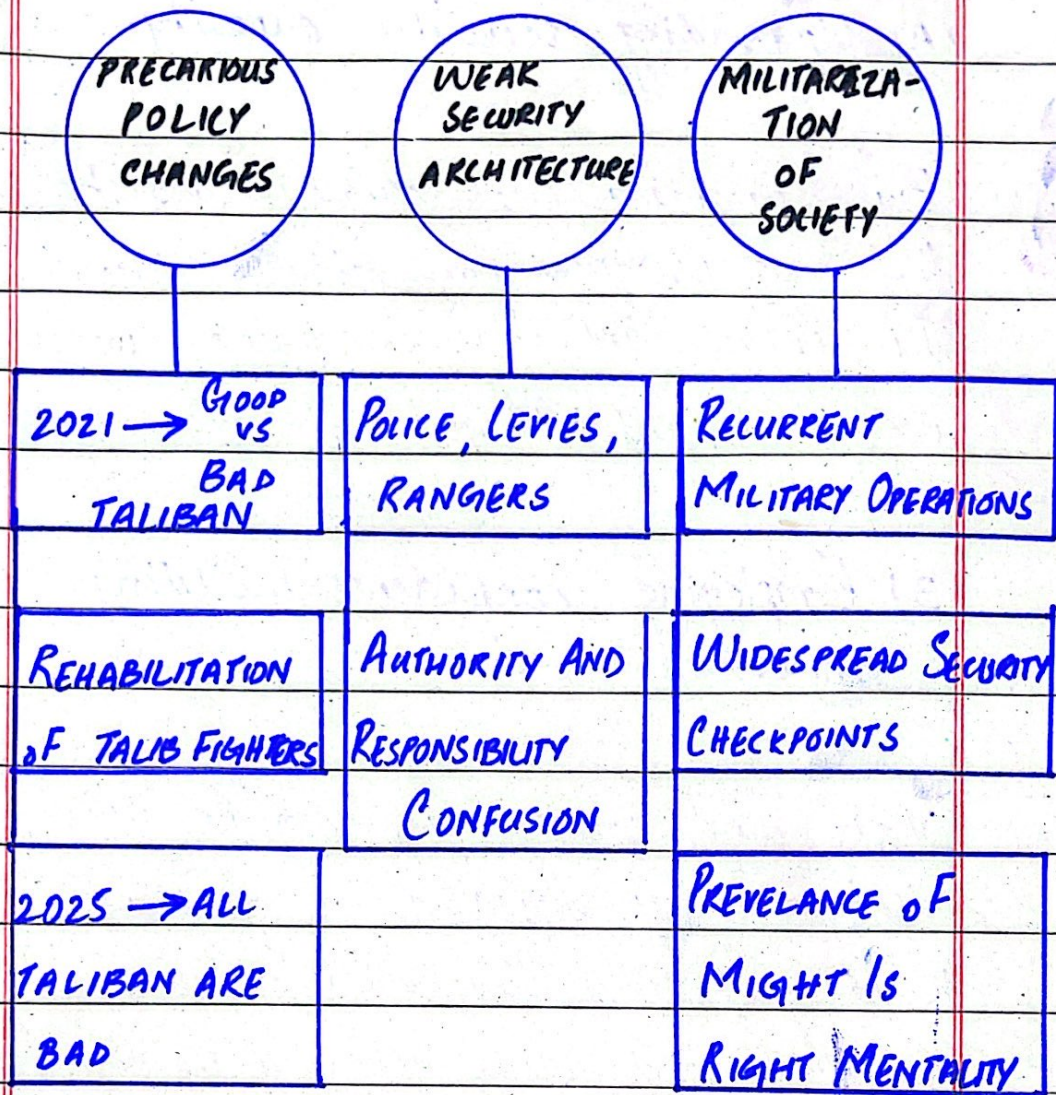
Militants take advantage of the deplorable economical situation of these 2 provinces. Both Balochistan and KPK continually rank the lowest in education, health, gender, and infrastructural capacity related rankings. The Jhal Magsi district of Balochistan has

rankings comparable to the likes of Sub-Saharan Africa. This economic disparity gives credence to revolutionary fervor.

(E) Youth Radicalisation

AA Upwards of 60% Pakistanis are below the age of 30. Without legitimate sources to earn, people resort to illegal and immoral acts. According to the UN report, "Transnational Terrorism in South Asia", published in 2023, the TTP were offering \$300 per month salary to their fighters. This amount is much more than the starting salary of an MPhil degree holder, consequently radicalising youth.

(III) Policy recommendations for mitigation

(A) Upgrading security capacity

By upgrading the security capacity the two provinces can mitigate militancy. This entails anti-terrorism training, modern weaponry, and intelligence sharing.

(B) Employing confidence building measures

State and society can reconcile their differences by engaging in confidence building measures. Information transparency, accountability and judicial autonomy are such measures.

(C) Developing marginalised areas

The development of traditionally lacking areas would give many disenfranchised people a stake in the system. Consequently, this would diminish the appeal of ~~ter~~ militancy, and inculcate the need for protecting the status quo.

(D) Enacting long-term security policies

Formulating long-term—around 10 years or more—security policies, along with the support of the stakeholders, can mitigate the ~~issues~~ ^{security lapses} caused by policy reversals.

(E) Streamlining security structure

By formalising and streamlining the security structure, preventable lapses can be mitigated. This ^{entails} either formalising the use of paramilitary forces or empowering the police.

(F) Fortifying Eastern and Western borders

The active patrolling and further fortification of the two hostile borders can prevent militant crossings.

More personnel should be posted to border areas, and tighter security measures should be enacted.

(G) Implementing the National Action Plan

The 14-point National Action Plan is a comprehensive framework for mitigating militancy. It encompasses political, governance, socio-economic, and security recommendations.

(IV) Conclusion

In essence, owing to a myriad of internal and external challenges, Pakistan, in particular its ^{two} ~~two~~ western provinces have been swung to the forefront of militancy. 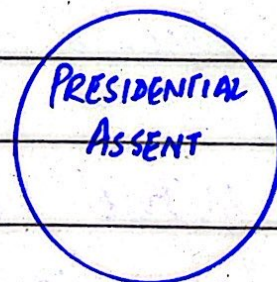

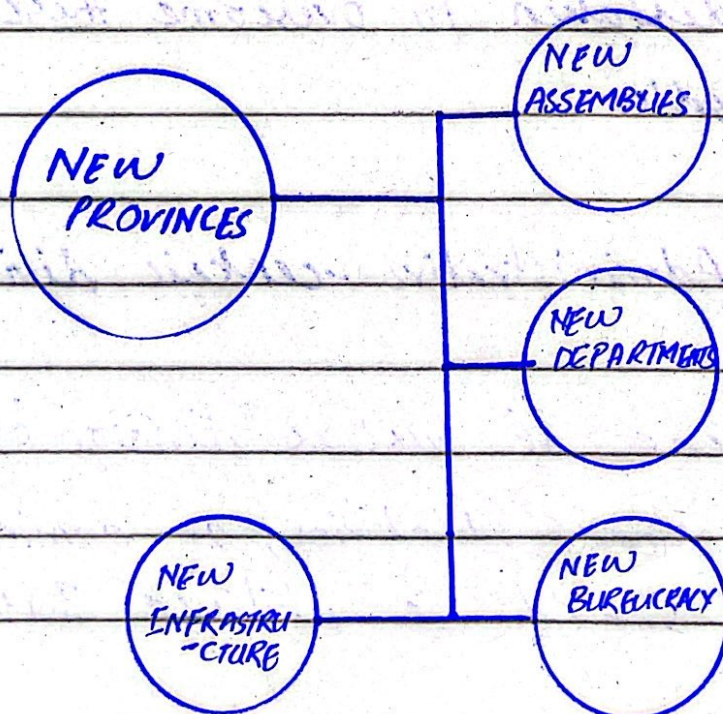

(B) Utilising a region-specific approach.

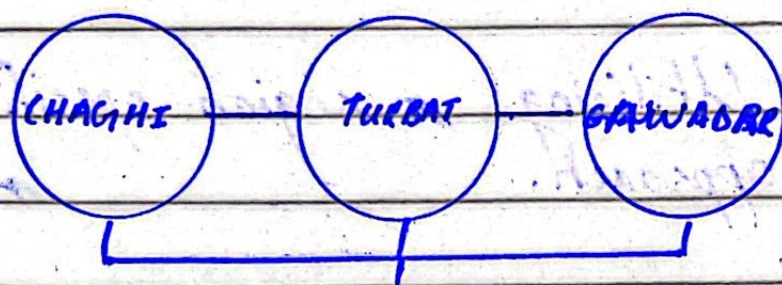
This means no division not for division sake but on the basis of targetted and on-ground reality based approach. Balochistan despite its size should not justify division, and Punjab despite is small geography requires division.
