In an era of unpredictably mainly ushered by Trump, China is trying to project itself as a reliable partner. Critically evaluate the statement and China's capacities to a parallel world order.

(A) Introduction

In recent years, the global has been undergoing a phase of flux due to Trump's unpredictability administration. There is growing uncertainty in the international politics. Trump administration's unpredictable policies such as exit from Climate Change Agreement, trade wars, Exit from Iran nuclear deal, withdraw from Trans Pacific Partnership, contradictory statements on NATO and specifically "America First doctrine" created strategic vacuum across institutions of global governance. Against this backdrop, China has sought to present itself a reliable and strategic partner of providing economic, diplomatic and institutional alternatives to the US-led order. China is trying to project itself a reliable partner by proving itself champion of

globalization, builder of global infrastructure. Such as BRI, Multilateral leadership active role in UN, WTO, WHO and climate negotiations. Creation of BRICS, AIIB to reduce the economic hegemony of USA.

(B) Critical Evaluation of unpredictability ushered by Trump:

1. Withdraw from Multilateral Commitments:

Trump's abruptly withdraw from major international agreements such as **Paris climate accord** and lack of participation in the **COP30**.

Trans Pacific Partnership (TPP), goal was to create a free trade zone area,

Iran Nuclear deal (JCPOA) Joint comprehensive plan of Action; between Iran and P5+1 to limit Iran's nuclear capacity in return with Sanction relief. Moreover, US ended all fundings

UNRWA (UN relief and work agency),

INF Treaty (Intermediate Range Nuclear forces), indicating a break from long-standing US commitment.

2. Reversible of foreign policy Decisions.

Frequent policy shifts and reversal, such as announcing troops withdrawal from Syria and then partly reversing them, created a confusion between allies and adversaries regarding US intentions.

3. Rise of America first protectionism:

The "America First doctrine" led to tariffs on Steel, Aluminium, imports from allies including the EU, Canada and Mexico

25% tariffs on Steel, 10% on Aluminium, launched a trade war with China, targeting goods over **\$370B**, prioritized domestic industries.

4. Strained Relations with Traditional allies.

Trump repeatedly criticized the NATO members for not "paying the fair share", threatened to withdraw troops from South Korea and Japan if the allies did not increase defense

Spending. Moreover, public condemnation of European Union policies and imposition of tariffs on EU goods including air crafts. ~ Council of Foreign Relations

5) Sudden unilateral Trade Wars and Tariff Escalation:

In 2018, 2025, U.S imposed unilateral tariffs on major economies. USA imposed **10%** baseline tariff on most imports from almost all countries.

6) Institutional Disengagement from global governance:

In 2020, the Trump administration announced the withdrawal of the US from the World Health Organization (WHO) during the COVID-19 Pandemic. Moreover,

USA blocked appointments to the **WTO Appellate Body**. In

addition, Trump administration blocked funding and engagement with **UN Agencies** including

UNICEF and **UNRWA**. Also,

Criticized NATO and UN framework.

(B) China Trying to project as a reliable partner:

1. China as a champion of globalization and Multilateralism:

Chinese leaders have consistently spoken in favour of an open world economy and reaffirmed commitment to **Paris Accord, UN, WTO**. China filled the power vacuum created by USA while withdrawing from these global Multilateral Organizations. ~CRF

2. Establishing partnerships With EU and Asia via BRI:

China's Belt and Road initiative is connecting the 3 main continents which are Asia, EU and Africa bypassing the USA hegemony in South China Sea security concerns. BRI spans **150+** countries with investment over **\$1 trillion** in infrastructure, energy and transport. (~WB Report, 2021)

3. Establishment of Alternative Multilateral institutions:

China is establishing Alternative multilateral institutions such as **BRICS** which is expanded

to **BRICS+** by involving 6 more countries. China established **NDB** (New Development Bank), **SCO** and **AIB** as an alternative to WB and other western led institutions. Moreover, China's trade with other countries is in its local currency bypassing **US dollar**.

4- Technology and Economic influence: Investment in Clean energy:

China is providing compensation of **\$100B** as USA withdrawl from clean energy investment.

Moreover, China is leading in 5G, AI, EVs, exporting via digital Silk Roads. China is shaping global economic and technological dependence, reinforcing a parallel order. ~ **Brooking Institution Report**

5- China a reliable partner regarding Military, weaponry trade:

China is the World's fifth largest arm exporter, supplying weapons to Pakistan, Africa and Myanmar. Fighter Jets, Missiles, Naval vessels, Air defense systems, Surveillance drones and missile systems.

China's arms export account for **5-6%** of global arms export according to **SIPRI**. Arms exports strengthen China's strategic footprint in South Asia, Southeast Asia, Africa, complementing economic initiatives like BRI.

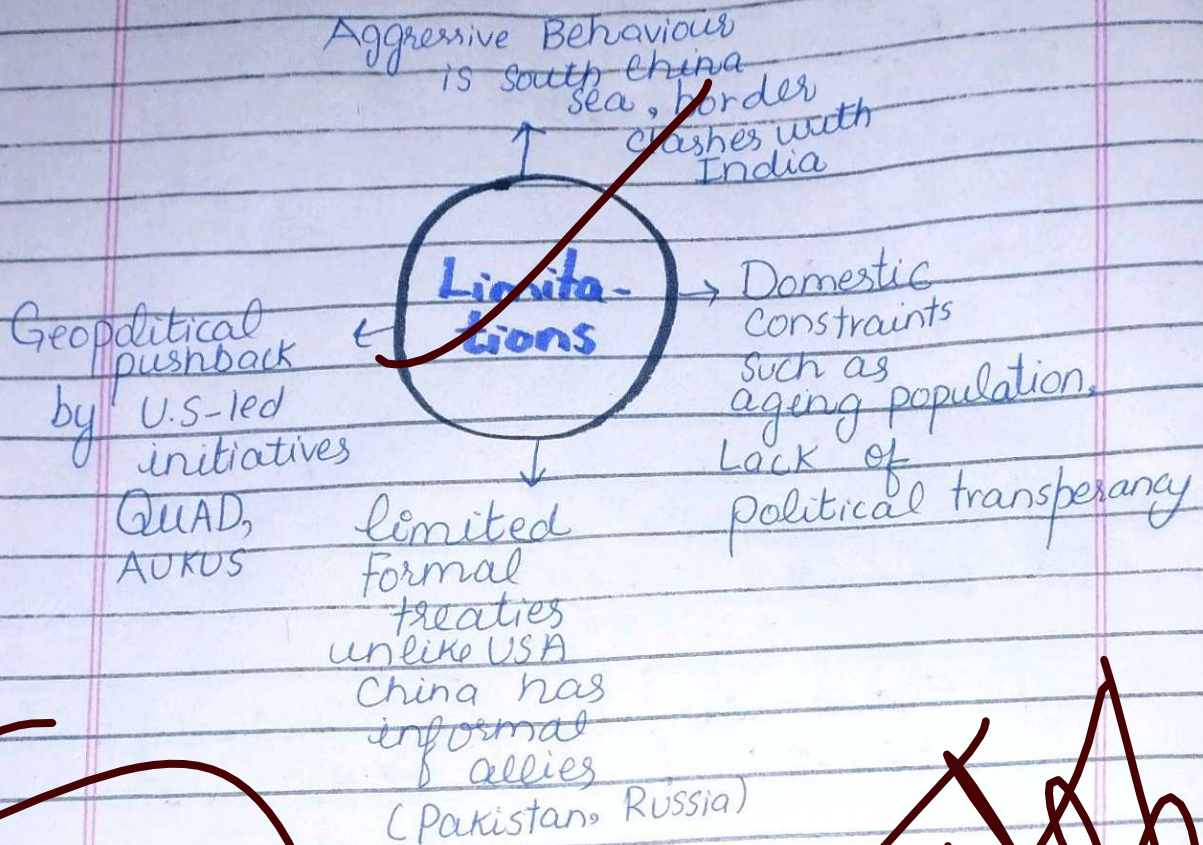

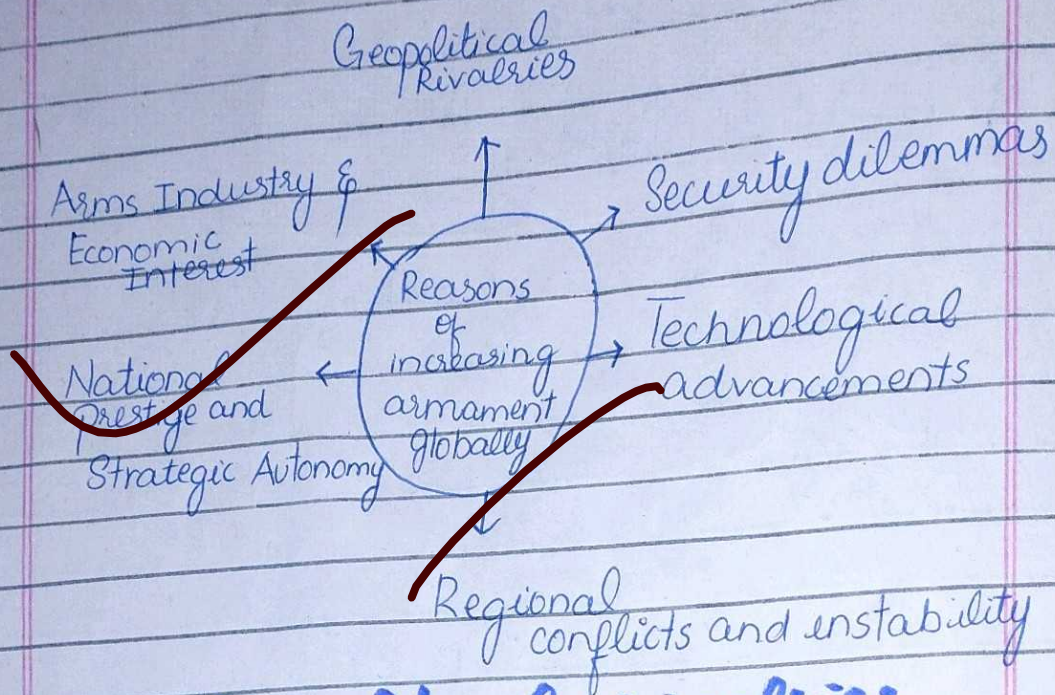

There is an increasing armament across the world. Critically evaluate the reasons and implications for World peace.

A) Introduction :

The contemporary world is witnessing a significant increase in armament, spanning conventional, nuclear and emerging weapons. Despite international treaties and disarmament efforts, global Military expenditure is projected to increase following a record **\$2.7 trillion** in **2024**, according to **UNDP**. Factors driving this trend include ongoing conflicts, rising geopolitical tensions and increased spending in regions like Europe and the Middle East. Factors such as resurgence of Great power rivalry, technological advancements and pursuit of National prestige and Strategic Autonomy are also driving states to modernize and expand their arsenals. This escalating militarization poses serious challenges to the world peace and stability.

(B) Reasons of increasing armament globally:



(1) Geopolitical rivalries and great power competition: a key driver for increasing armament:-

Geopolitical rivalries and great power competitions globally enhanced the armament. **US defense spending reached \$871B in 2023, China \$293B and Russia \$86B**, depicts a Strategic competition for global influence. Rising Tensions between

US-China, India-Pakistan, Russia-Ukraine, NATO Expansion, Sudan-RSF, Armenia Azerbaijan push states to expand capabilities to assert influence.

AI-enabled drones, Russia's

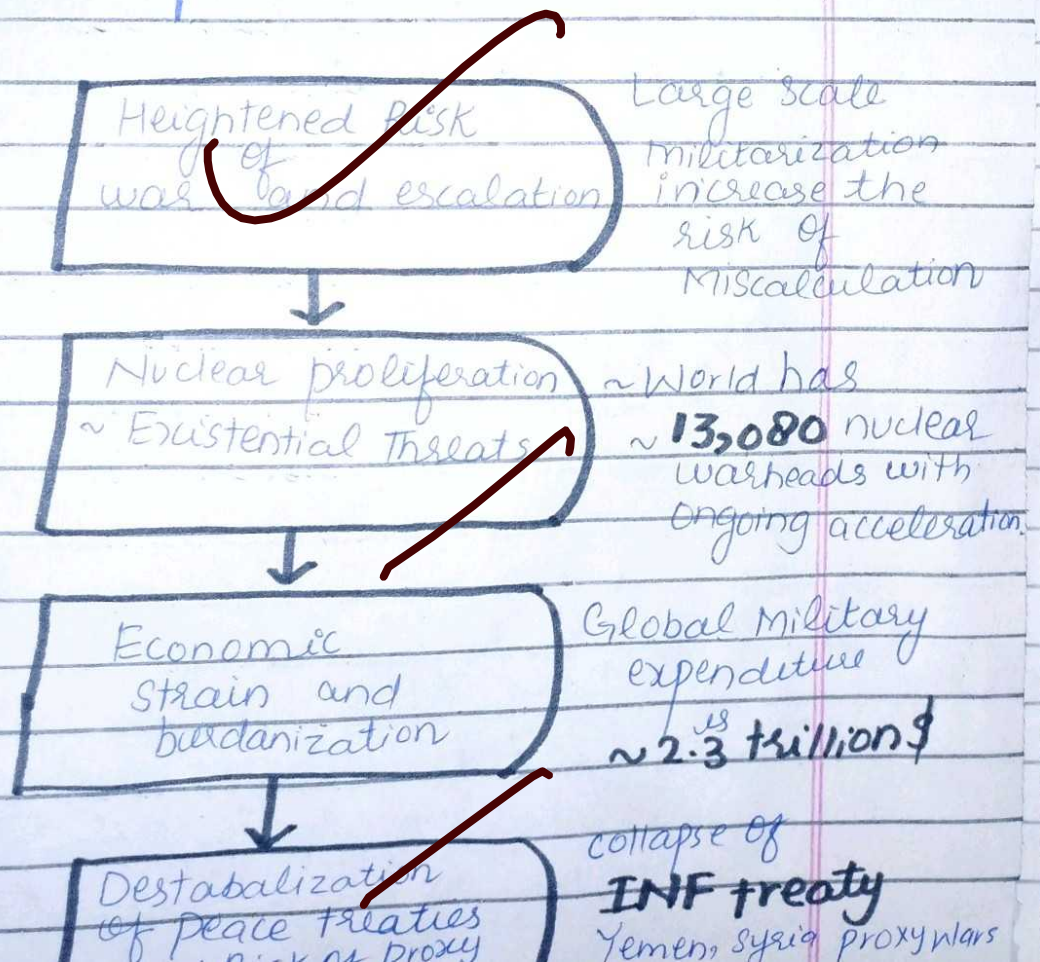
hypersonic Missiles like Avangard
