1) INTRODUCTION.

Since the inception, Pakistan has been oscillating between the Presidential and Parliamentary forms of governments. Both of the systems have their strengths and weaknesses. But for a state to run efficiently, it must settle for one and develop its roots. Due to the shifts between the two forms of systems Pakistan has faced serious repercussions. Political instability, patronage politics, weak institutions, democratic weakness, institutional imbalances, short-term stability and long term instability. The lessons that can be drawn from these pendular movements are that; democracy requires institutions, not just systems, the root-cause of the problem is the civil military imbalance, political

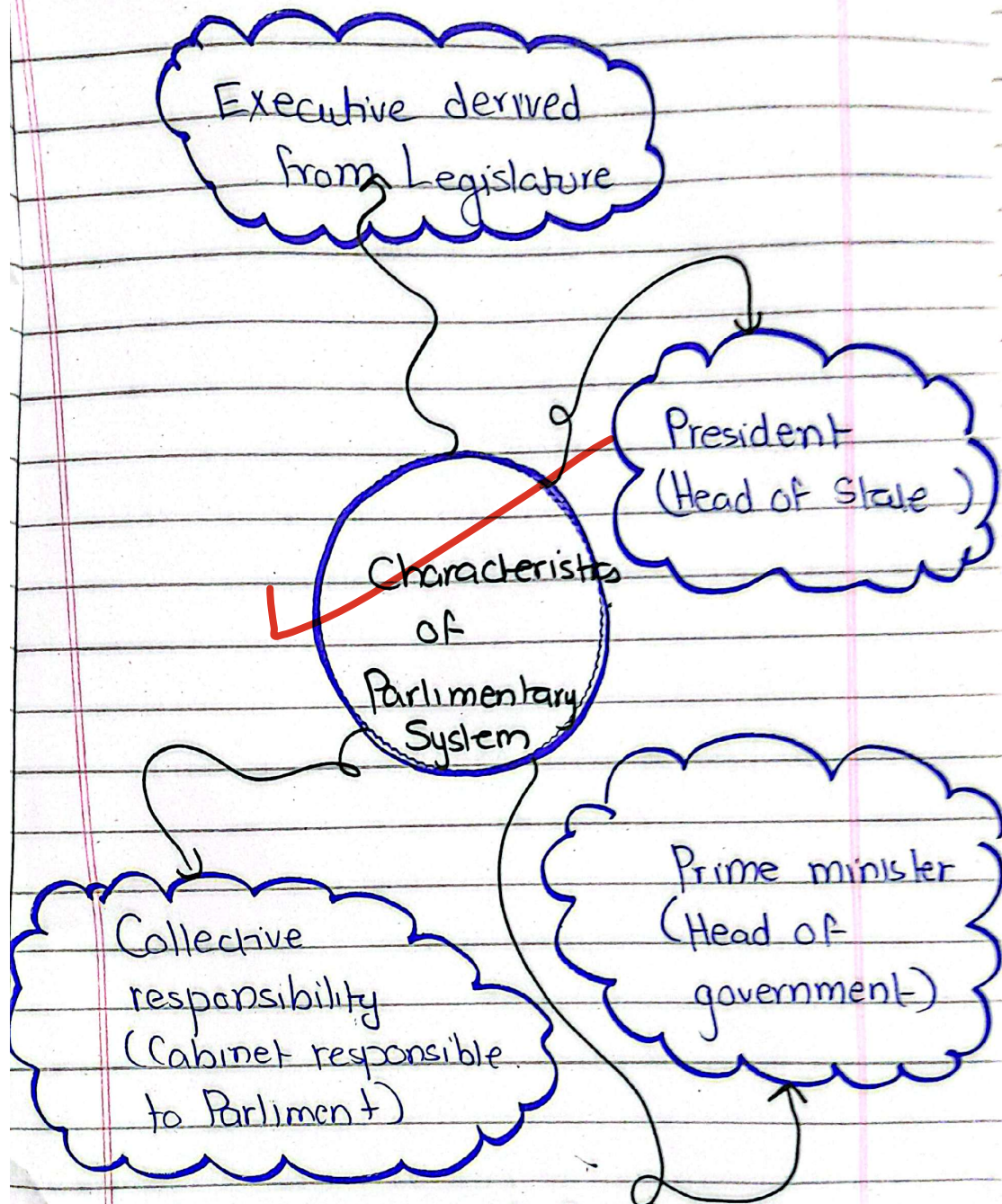
maturity is the key to long term development. Along with this, balance of power and constitutional supremacy matters alot. And the most important lesson is that Pakistan suffered alot- because of the exclusive policies and politics along with weak system of local governments. All of these problems must be addressed if Pakistan wants to become a strong and prosperous state as today Pakistan has a stable constitution but- the problems are still the same.

2) Oscillation between the Presidential and Parliamentary Systems.

(i) Parliamentary form of government

The Parliamentary form of government, like a Presidential form of government, have some characteristics that creates distinction in the two forms of governments.

a) CHARACTERISTICS OF PARLIAMENTARY RULE IN PAKISTAN.



(i) Executive derived from the Legislature.

The Prime Minister is elected by the National Assembly and is accountable to it.

(ii) Collective responsibility

The cabinet of the Prime Minister is responsible to the Parliament.

(iii) President: Ceremonial head of the state.

The President's role is ceremonial according to the Constitution of 1973. He is the ceremonial head of the state.

(iv) Prime Minister: Head of the government.

Prime Minister is the head of the government and performs the executive role along with his Cabinet.

Democratic accountability pertains that the executive remains answerable to the Parliament.

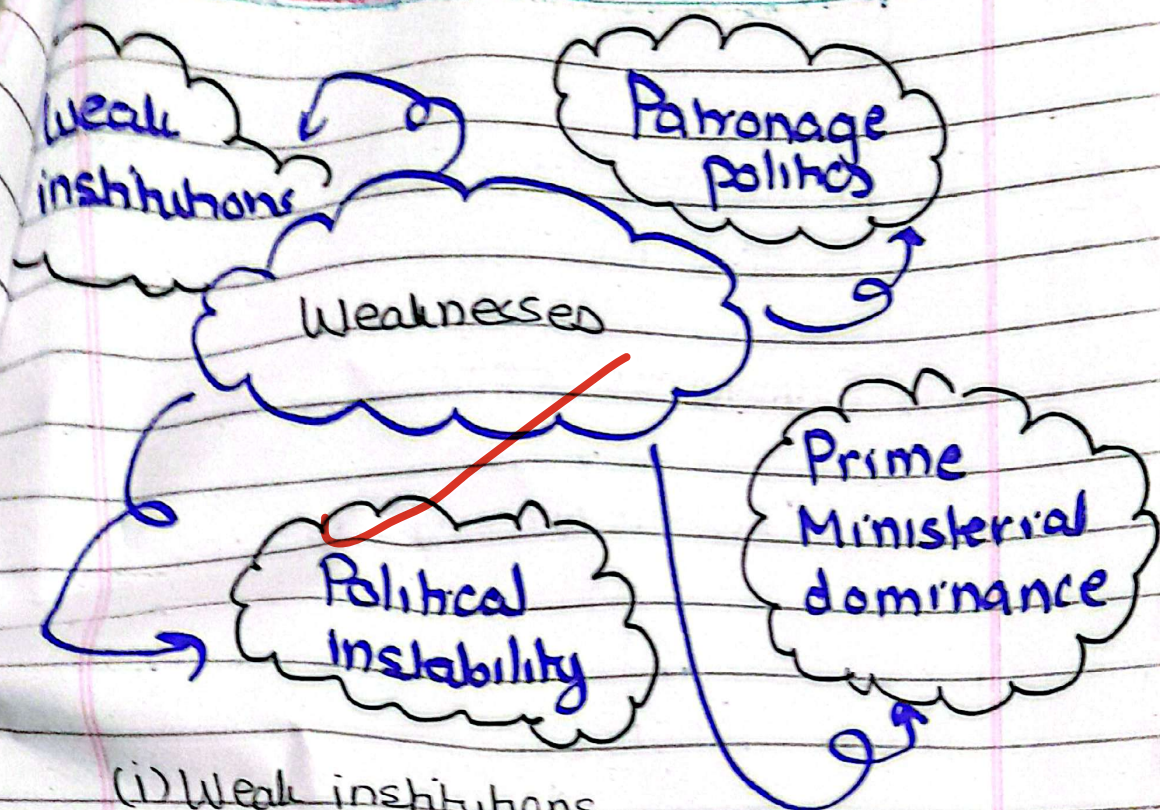
(ii) Representative governance

b) WEAKNESSES IN THE PARLIAMENTARY GOVERNMENT

Along with the strengths of Parliamentary form of government, it has certain setbacks that was faced by Pakistan.



(i) Weak institutions

At the time when the civilian government seemed ineffective, bureaucracy and military took the stage.

(ii) Prime Ministerial dominance.

The Prime Minister was backed by a great majority. due to this, he often sidelined the institutions.

(iii) Patronage politics

The Parliamentary system imposed a feudal and patronage

political culture.

the Parliament.

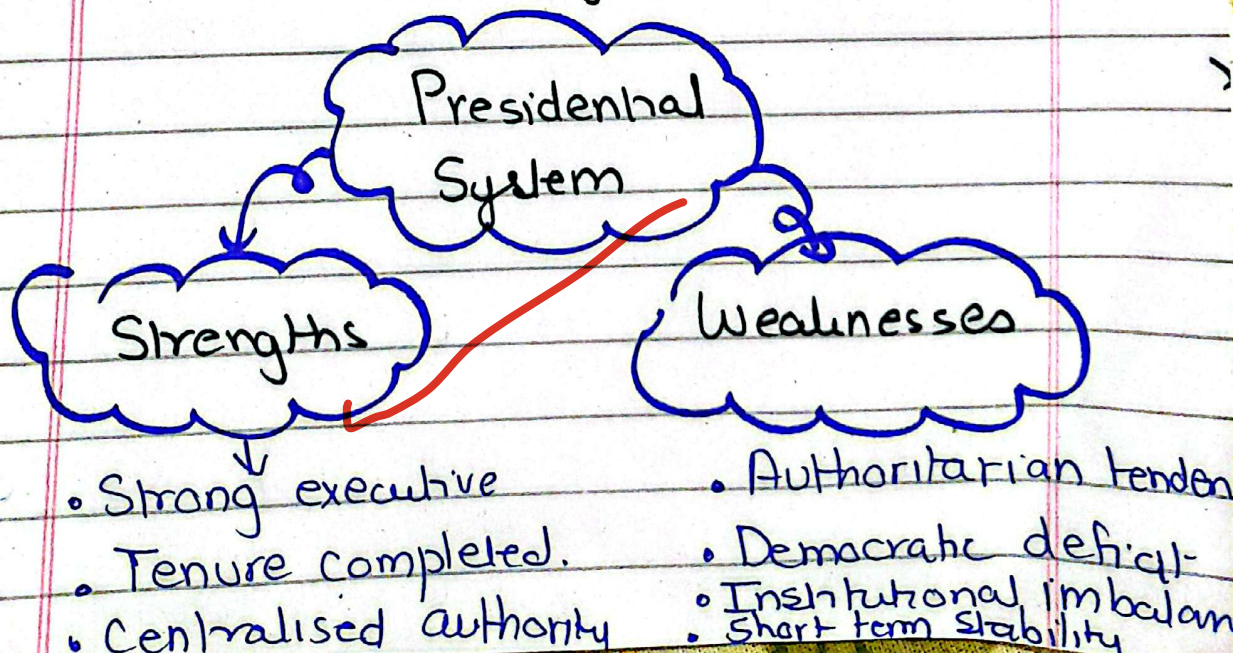

(i) Strengths

(i) Strong executive

In Presidential system the executive is strong & which provides stability and ~~at~~ decisiveness especially in the case of an emergency.

(ii) Stable government: Tenure Completed.

In Presidential form of government there is a reduced risk of frequent government collapses as the President cannot be removed by the vote of no confidence by the Parliament.

(iii) Centralised authority of the President.

Through the centralised authority in the hands of the President, the decisions and policies can be efficiently executed which gives impetus to growth.

(ii) Weaknesses in Pakistan's experience.

(i) Authoritarian tendencies of the President

The centralised authority is in the hands of a single person: The President. The Presidents under this system ruled autocratically.

(ii) Democratic deficit.

This form of government limits the political participation and suppresses the opposition.

(iii) Unbalanced approach towards institutions

Under the Presidential government, the other institutions like, judiciary, parliament and media were undermined which created an institutional imbalance.

When the rule of the dictator ended it resulted in turmoil and public unrest.

(i) Democracy requires institutions

Both the systems failed when the institutions; such as judiciary, parliament and election commissions, were weak.

(ii) Main problem: Civil-military imbalance

Repeated military interventions distorted both systems because the genuine civilian supremacy was difficult.

(iii) Need for political maturity.

The patronage based politics must be abolished. The political parties must internalise democracy discipline and long term policy making.

(iv) Balance of power brings stability

Concentration of power under PM or president undermines the checks and balances which undermines stability.

(v) Constitutional stability matters

Frequent amendments and abrogations led to the eroded legitimacy and the public trust in the constitution.

Local governance and inclusion politics

Strong ^{local} governance and inclusion politics can reduce the centralisation of powers and strengthen the democracy at the grass root level.

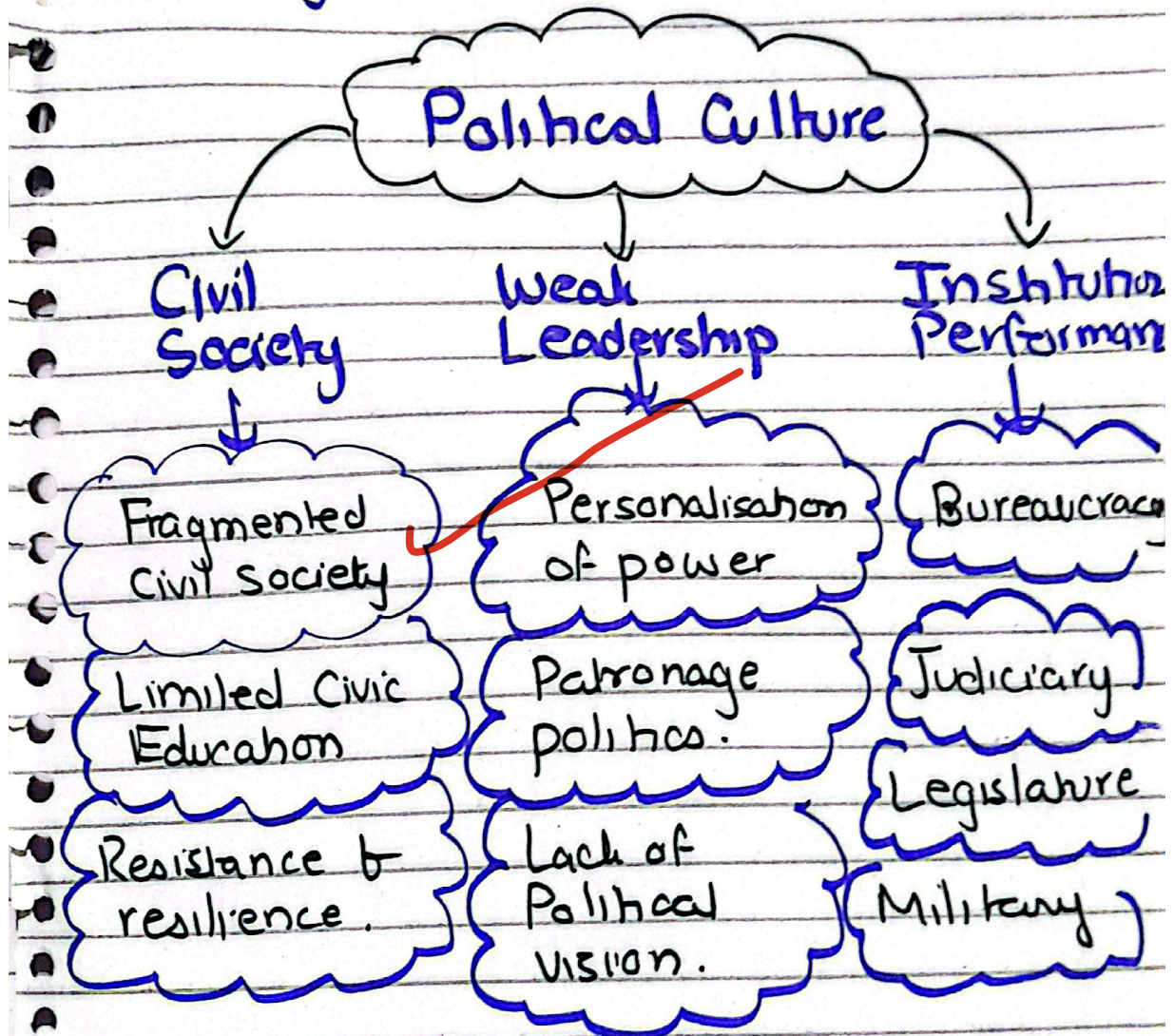

1) Role of Political Leadership

a) Personalisation of power.

The political leadership personalises the politics rather than institutionalising it. The politics is embedded in ~~patronage~~ dynastic governments rather than

around ideologies and manifestos.

b) Patronage politics.

The governance has become transactional which serves networks of supports not the citizens at large.

c) Lack of political vision.

Short-term policies are made because the parties use populism as their narrative with weak intra-party democratisation and they are focused on survival rather than bringing reforms which has undermined the policy continuity.

2) Role of Civil Society.

(i) Weak and fragmented civil society

The civil society of Pakistan lacks cohesion and depth. The organisations working in the country are disconnected from the grass-root level.

(ii) Limited civic education

Low literacy and political awareness ~~means~~ makes the citizenship ^{vote} ~~to~~ the basis of ethnicity and tribal influence rather than on policies and the performance of parties.

(iii) Resilience and resistance is periodic not reformative.

The movements and media activism for the rights of the people are for a short term and do not bring any reforms in politics.
