Principles of Good Governance in Islam:

1- Islam Emphasizes Justice as the Cornerstone of Governance:

a- Justice as Divine Command:

Islam makes justice obligatory for rulers because it ensures fairness and prevents oppression. It creates public trust by protecting the rights of

b. Imperial and Universal Justice

Justice prevents rulers from becoming dictators and protects citizens from exploitation and abuse. As Hazrat Umar (RA) stated,

2. Islam promotes Consultation in Governance:

Shura ensures that government decisions reflect diverse perspectives. It promotes inclusiveness and improves the quality of policies.

Quran commands,

'Their affairs are decided by consultation' (42:38)

This makes collective decision-making an Islamic duty. The Prophet (PBUH) consulted companions in matters like Uhud and Khandaq.

3. Islam Requires Accountability of Leaders:

"Each of you is a shepherd and responsible for his folk" (Hadith)

Leadership is a trust (amanah) that comes with moral accountability. Islamic governance discourages bribery, nepotism, and misuse of power. Rulers will be questioned by Allah for misuse of authority. Hazrat Umar

4. Islam Upholds the Rule of Law:

"Judge between them with justice; do not follow desires" (5:49)

Through Quran, Allah prevents judges and rulers from making biased decisions. Islam rejects legal privilege for the rich or elite. All individuals, including rulers, are equally subject to law.

5. Islam Ensures Protection of Human Rights:

Human life is a sacred in Islam, making its protection a state obligation. Islam also ensures legal protection for minorities, rejecting racism, tribalism, and caste-based privileges.
