(i) Focus On India as Primary Security Threat

Pakistan's focus on India as primary security threat like, wars in 1948, 1965, 1971, Kargil (1999) and May 2025 border escalation show Pakistan prioritizes military deterrence.

SIPRI 2024 notes defence spending exceeds 3% of GDP, limiting regional initiatives.

Pakistan's nuclear arsenal deters conventional threats and maintains regional credibility. IAEA 2024 reports Pakistan's nuclear program is among the fastest growing in South Asia. Although, it diverts resources from regional cooperation.

Pakistan provided logistical and intelligence support to NATO forces to stabilise Afghanistan while maintaining influence in Kabul. USIP 2013 notes Islamabad sought to protect western borders while engaging diplomatically.
