

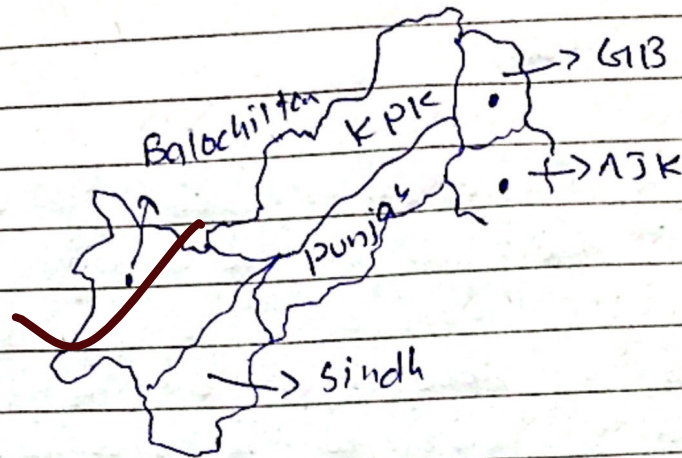
## 1. Introduction

Decentralization of power through creating new administrative units has long been under discussions in the vast corridors of powers in Pakistan. From One Unit Schemes to four provinces under federal form of government, Pakistan yearns for crafting more provinces. However, economic, security, and administrative challenges pose threats. Therefore, carving out new provinces need meticulous process, plan, program and policies on administrative and legal grounds rather than ethnic and identity based regionalization.

## 2. Historical overview of Pakistan's geographic division:

Pakistan has adopted the one unit formula to manage the state as Eastern Bengal and western Pakistan as two domains, which later proved to be a futile effort in maintaining a federal structure. Later on Pakistan adopted one plus four formula as Islamabad as center, encompassing four administrative units and territories.

**4. Prominent Hurdles in the way:**

Pakistan has to face brunt of ethnic and legal hurdles before moving towards creating smaller unit.

**(a) Economic cost is too high:**

Creating new provinces need enough economic support. As at present Pakistan faces debt crisis. Amidst such scenarios creation of new provinces is impossible task. For example, Pakistan had to bear \$6 billion rupees cost while changing the name of the NWFP to the KPK.

This shows that economic uncertainty in Pakistan is a mighty hurdle.

**(b) Open Gates to other powers to demand more provinces**

There are possibility of creating a few provinces. However, if Pakistan manages to create a few provinces on ethnic grounds. It is possible that other region<sup>my</sup> claim their own provinces.

For example: Sindh can demand for separate upper, lower, Karachi, Muhajir, & urdu speaking areas as new province.



### c. Regionalization may become Pervasive:

Pakistan already faces the regionalization of Province. A few Parties promote their Political agendas. This may lead to disintegration or regionalisation. For instance, BLA in Balochistan wants a separate area for it. Other Political Parties including the PML-N and PPP have failed to make a mark at national level.

### d. Administrative burden:

New Province may need more officers and ministers. Poorer regions may face lack of quality people.

### e. Displacement and dispute:

New Provinces may lead to huge migration and property dispute. As today, other smaller units alleged Punjab for resource exploitation.

### f. Legal challenges:

New Provinces need permission from concerned and respective Province to pass resolution. Similarly there is need of amending constitution too.
