Zakat: Zakat is the one of the five pillars of Islam, an obligatory annual giving of fixed percentage of one's wealth to poor and other specific causes. Zakat is not a charity

9- outlines that are not self explanatory or does not aligned to with the essay statement are liable to mark 0 and the essay would become null and void

10- always try to be relevant to the topic, if even your 1 or 2 arguments are irrelevant, the examiner would not pass your essay.

In one of the biggest charity scam cases in American history, four cancer charities were caught embezzling over \$187 million in donation

Misuse of NGOs Aid dependency:

Example: Benazir income support program.

The heads of these schemes are corrupt and they used to do the corruption. They use the money for their personal gains.

Causes of Misuse:

⇒ corruption:

The root cause for the misuse of charity is corruption. Most of the people have the habit of corruption.

⇒ Poverty:

Poverty can cause the problems for a poor man. Poverty is the root cause of corruption.

Solution:

⇒ strict regulation:

To prevent the charity as poison

government should have strict regulation on each and everything

⇒ Financial Transparency:

Financial transparency is necessary to prevent the misuse of charity. Lack of transparency is the cause of misuse of charity.

⇒ Regular Audits of NGOs.

Regular Audits can create fear in NGOs. Check and balance is necessary to run any organisation.

⇒ Strong governance:

Strong governance can help the countries to break the cycle of dependency.
