Constitutionally, the 17th Amendment (2003) legitimized Musharraf presidential power, including the authority to dissolve assemblies, thus weakening parliamentary supremacy. However, public demanded

The 18th Amendment (2010) was a landmark development, restoring parliamentary power, reducing presidential authority, and enhancing provincial autonomy, which significantly strengthened domestic continuity and federal governance. Judicial activism also gained prominence during this era, with the judiciary asserting its independence, notably during the Lawyer's movement (2007-2009), which restored chief Justice Iftikhar Chaudhary.

Structural Weaknesses Reinforcing the crisis :-

while political economy issues dominate, structural flaws magnify their impacts.

- Narrow Tax Base :- only around 20% of Pakistan pay direct taxes.
- Low Export Base :- Heavy reliance on textiles and remittance keep the economy vulnerable to external shocks.
- Energy Inefficiency :- The circular debt exceeds PKR 2.6 million trillion, crippling the power sector.
- Import Dependence :- food, fuel, and machinery imports widen the trade deficit.

Empirical Indicators of the crisis :-

- GDP growth has fluctuated between 1.5% and 3% in recent years.
- Inflation soared above 25% (2023-24) eroding household incomes.
- Repeated IMF program (24 since 1958) show

persistent failure failures and weak reforms implementation.

- In 1973 Constitution made Islam the State religion; attempt to unify masses according to Islamic point of view.

- Zia-ul-Haq Era (1977 - 1988) :

- period of state-led Islamization
- Hudood laws, Sharia courts, and compulsory Zakat.

- Democrated period (1988 - 1999) :-

- political parties invoked Islam as point to take votes.

- Ideology become politically fragmented.
- Post - 9/11 and Musharraf Era
(2001 - 2008) :

- Islam link with global Image and counter-extremism narrative.

- Contemporary Era (2008 - present) :
