it is mainly justified through the cultural and traditional practices, patriarchal norms, economic necessity, social and family pressure and lack of awareness and legal enforcement.

The, 2016 Express Tribune article of 13 people arrested for the forced marriage of an eight year old girl to settle a family dispute, this directly links to the traditional and cultural practices such as Swaro de Vani in which women are given in marriages to resolve the disputes.

Also, that women are forced into marriage to strengthen the family ties and to maintain alliances that may support in the political or social image, cousin or intra-family marriages are one of its examples, they are done to preserve the property and to maintain the family purity.

During the 2022 ~~wars~~ floods in Sindh, around 26 girls of the same village were married of age younger than 18. This explains that ~~mar~~ forced marriages are also encouraged because of the economic challenges. In this particular situations people lost huge valuables, those living in poverty are more forced deeper into it so the solution to reduce the burden or to pay off

the debt, people find is marrying off their young girls, girls are still liability on the family in many parts of the country so to get rid of the debt, they marry them off and also some families buy the bride

Moving on, Unmarried girls or women who are not married and remain unmarried forever are not much valued and respected in the society. So, the family pressure and social criticism leads to forced and unmatched marriages. It also includes the fear of love marriages, these marriages are still not appreciated and families reject such relationships and as a punishment women are forced to marry someone else. Love marriages are still ~~considered~~ taken as a disobedience from the girls or women. So, to keep the control and for the family honor they are pressurized into such unions.

Another cause is Illiteracy and lack of awareness. Further fuel is late justice and law enforcement in many rural areas, that becomes a barrier in women seeking legal help and fight for their justice.
