5- Avoid firstly, secondly, thirdly etc. in outline

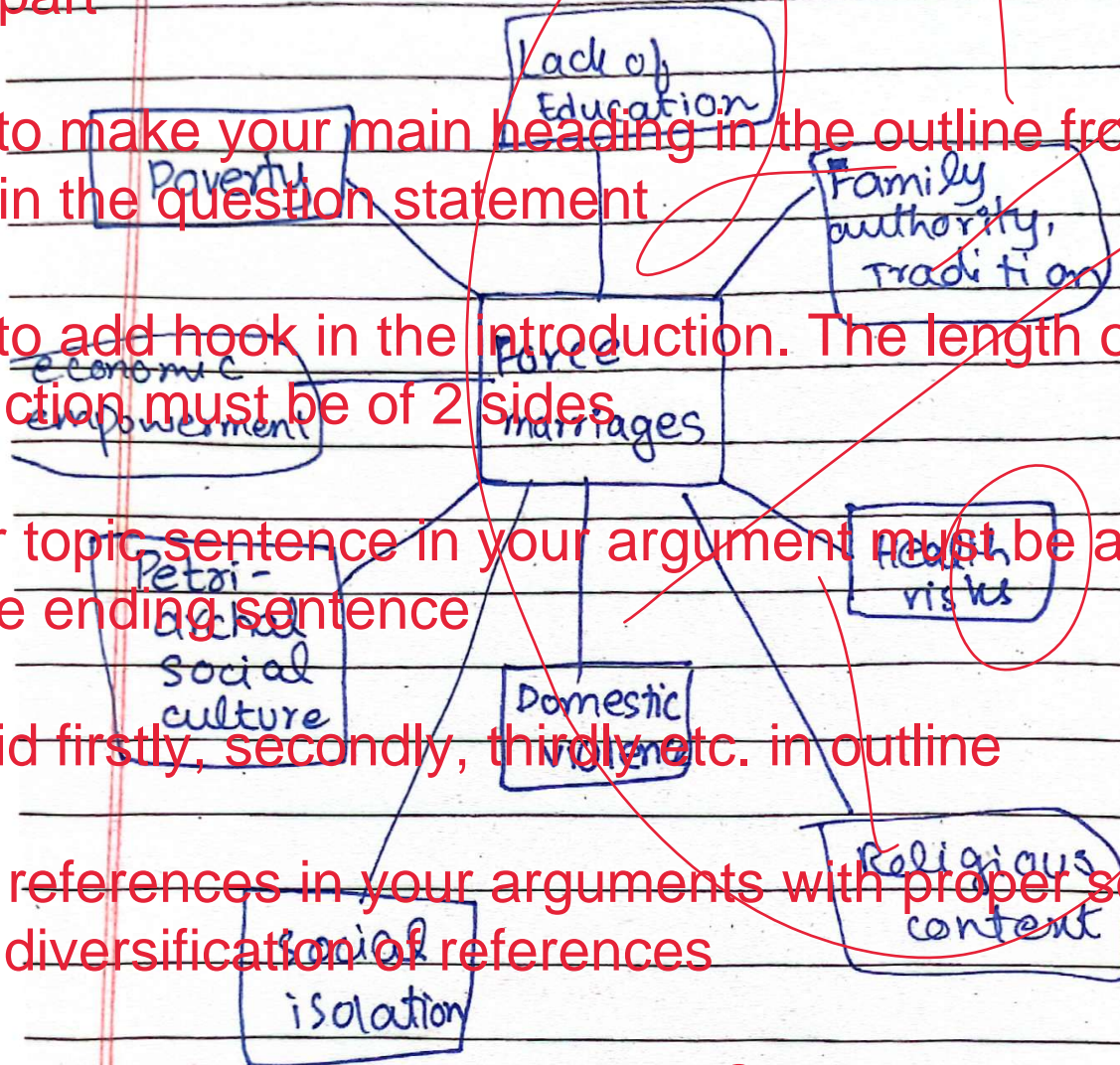
6- add references in your arguments with proper source. Go for diversification of references

As there is low income that will lead to exploitation of their children and family. Parents marry their daughters to reduce their burden but that leads to future exploitation. Parents believe that marrying their daughters early will reduce household expenses such as food, clothing, education costs. Their mindset turns marriage into strategy for survival than a choice based on maturity. Poor families fear that their daughters might face dishonour if left unmarried. To protect their "honour" they marry them.

Strong norms favour marriage within caste or social class & are used to keep property in their family. In many traditional families of Pakistan, property & inheritance are central to social power & family honour. To preserve land, wealth & family assets within same

Honour in society, prioritize maintaining relationships within the caste than allowing children to choose freely. Fear of gossip, dishonour leads to arrange marriages quickly.

In a globalized world, many Pakistani families consider marriage to a foreign national a shortcut to financial stability & immigration opportunities. Desire to gain the foreign nationality, residence often leads families to force young women into arranged marriages. Families with relatives living in countries like UK, Canada compel their daughters to marry. They often want to secure a visa, citizenship or better financial support from overseas. These marriages are less about the Family Bonds & more about economic & legal advantages. And a Foreign family is

generally considered as a symbol of success. Parents believe it will elevate their social status. Such marriages end in abuse, emotional isolation & loss of autonomy.

One of the consequence is Health risks. Force marriage expose

individuals especially young girls to severe physical, reproductive Health risks. Since such marriages

Similarly, forced marriages also lead to Early Pregnancy & maternal complications. Girls forced into

marriage at a young age are pushed into early Pregnancies while their bodies are not Biologically mature enough to Handle child-

Birth. This results in High maternal mortality rates, anemia & other

complications. Child born to very young mothers are more likely to suffer from low Birth weight,

malnutrition, lack of maternal Health Education & poor access

to Healthcare in such marriages worsen child Health outcomes. Force marriage deeply affects a person mental & emotional well-being. Being force into marriage means losing control over ones personal life decision, That leads to feelings of helplessness,

anxiety. Many victims experience depressive episodes after being married. Loss of autonomy and exposure to marital rape and abuse create mental harm.

Force marriage deeply affects an individual life especially women in a way that leads to trauma, psychological distress, identity conflict and many other causes.

Forced marriages often leads to abrupt end to educational opportunities especially for girls. Once married young brides are expected to take on domestic, childcare &

Family responsibilities that end in no freedom or support for continuing their studies. In most of the cases girls get married before completing their studies. After marriage, women face

restrictions from their husbands or in-laws who view education as unnecessary or inappropriate for married women. They discourage attending college and professional training institutes cutting off path to empowerment without Education, women have limited access to the employment & remain financially dependent on their spouse or families.

Forced marriage often becomes a breeding ground for domestic violence, as it join 2 individuals without understanding or compatibility.

When one partner is emotionally unprepared and relationship lack Trust & respect that leads to conflict, control & abuse. Force marriages lead to economic instability & Financial stress when individuals involve are too young, uneducated & unprepared for the responsibilities of married life.

most victims of forced marriages are forced to leave school before acquiring skills needs for employment. with little or no education, they cannot earn independently which leads to financial dependency on

spouses and in-laws. The cost of starting and maintaining Household with early pregnancy create severe financial strain. That pressure lead to conflict and domestic violence.

Yes, there are solutions available to mitigate forced marriages. As economic empowerment & social protection provide conditional cash transfers scholarships & livelihood programs for poor families so marriage cannot be seen as an economic necessity. Expanding girls access to Education will also decrease forced marriages Traditions. Similarly, Laws should be enforce to decrease rate of forced marriages.

Another option should be create a safe shelters, counselling services legal aid & medical support to survivors of forced marriage and associated abuse. Ensurance of protection should be mendatory. Religious leadership engagement must be done. Launching awareness campaigns that will clarify Legal rights and religious

position on consent that involve local religious leaders, teachers, community leaders to challenge Honour based norms.

Reform procedural barriers that allow victims to file complaints, train police, prosecutors & judges should response sensitively & promptly to force marriage case and specialized units should be established for complaints.

Force Marriage is not a private Family matter, it is multifaceted violation of rights that injures individuals and disrupt social development. Mandi Bahauddin case study paints clear picture:

poverty, patriarchal norms, endogamy, institutional neglect, ill-founded religious beliefs.

Effective prevention demands legal reform, community engagement, economic measures & survivor centred services combined with sustain political will. Only then, Pakistan move closer to securing basic human right of free choice in marriage for all its citizens.
