10- always try to be relevant to the topic, if even your 1 or 2 arguments are irrelevant, the examiner would not pass your essay.

Besides that the floods and rainfall water crosses through the region of Pakistan through the river system. The biggest river that originates from China, falls into the Arabian Sea by driving through the rivers of Pakistan. According to the Global Indicators, Pakistan lies in the TOP-10 countries that are vulnerable to climate change. Thus, in terms of all natural disaster, Pakistan is one of the most-affected country to the disaster climate change and natural disasters.

The irresponsible action from the government creates an environment of panic among the masses. However, if the pro-active steps were taken, both the disaster destruction and mass displacement could be minimized. People suffer financially, psychologically due to ~~displacement~~ and mass migration. They had to undergo various health issues and diseases due to this mismanagement.

The role of institutions like ~~NDA~~ National Disaster Management Authority, Building and Enclavement Authorities is unproductive. The response towards any disaster is after the disaster occurs rather than before the disaster took place. The various incidents such as, recent floods 2025.

~~During~~ After the Cloud Burst, the connection towards the remote areas of Khyber cut down. Instead of restoring the means, the institutions neglected the

neglect response. The social welfare advocates reached the affected area before the institutions that are responsible for this action. Moreover, the building crash in Karachi, that was built on an encroached area and was given lease to build a high-story building on a limited and illegal ground. The institution of Sindh-Building Control Authority ~~responded~~ took action when the building collapsed resulting loss of life and infrastructure. Similarly, there are several other building that are ~~built~~ built on illegal land and restricted criteria. The role of institution can mitigate this issue ~~is~~ by timely and strict response.

The budget allocation towards the disaster management is not enough. Similarly, the budget allocation for the infrastructure development is also important. Pakistan has ~~old~~ infrastructure that is out-dated. The current population need requires the respective budget for the infrastructure development. The sewerage lines, ~~in~~ roads, bridges are built ages ago. Those cannot meet the today's need. During the recent 2025 flood, the total infrastructure

Loss is upto **1981 Km** in which **200 bridges** are included according to the report of NDMA. This certain loss requires budget to be restored that the connectivity could be ensured timely.

The another drawback that is observed through out the years is that Government on foreign assistance after the disaster occur. Instead of working earlier upon the preparedness, the Government seek loan through the International forums. During the 2022 disasters, assistance of billion dollars was recieved through the COP meeting and ~~other~~ neighbouring countries like China. Thus, till the foreign assistance arrive, people suffer. This approach of disaster management is itself a challenge that accelerate the other challenges in Pakistan.

The recent conflict with India, Pahalgam Attack, India unamously abrogated the Indus Water Treaty 1960. This has resulted in water war. Further, India release the excess water into the rivers of Pakistan that results in floods. Such aggressive response

of the neighbouring country is affecting the socio-economic fabric of Pakistan. Pakistan has called this action of India's aggression - "**Water terrorism**". India is using water as a weapon. Due to controlled water flow, Pakistan faces droughts and during monsoon excess water is released into the rivers of Pakistan. Being an agrarian countries, whose **24% of GDP** is based on agriculture, is widely affected by such acts. This disrupts the crop yield and overall exports of Pakistan.

A menace created by private-housing schemes have added fuel to the disasters in Pakistan. These schemes are built upon the canals ~~and~~ that are specified to the water flow of crops and floods. ~~But the~~ Also, these are built on the proper ~~archil~~ planned infrastructure, the water of floods do not affect them, rather ~~the~~ it moves to the rural areas. Many of these are unlicensed and illegitimate. Therefore, the encroachment further creates the disastrous situation.

Disaster management cannot be done alone in isolation, however the public role is also imperative and

has equal responsibility. For instance, people throw their trash in the sewerage lines that blocks the flow. Thus, during rain, the sewerage lines get overflows that results in urban floodings. Another example is the **Muree incident**. NDMA blocked the roads towards the Muree due to heavy snow and over-crowd. People slept in their cars without the primary measures - resulted in loss of hundreds of lives. Thus, the role of citizens and mass awareness is crucial to address any disaster.

There are several countries in the world that are vulnerable to climate disaster. However few measures can help to address these challenges in Pakistan.

Proper Budget allocation is important to all the disaster management bodies. Inadequate resources, low salaries, out-dated technology cannot possess the ability to counter the disaster destruction properly and timely. Pakistan must allocate an adequate amount of budget to disaster management bodies. In addition to it, the revival and advancement of these institutions

is also important. Thus, Government must introduce the advancement program to introduce and integrate recent technology into these institutions to make it productive and functional.

Besides the budget allocation, the accountability of all the actions and working of NDMA must be taken place. A quarterly report must be given to the Prime Minister. In the report show all the measures and work done by NDMA to manage the disaster situation in Pakistan and its prevention. In this way, the NDMA can be productive and the disastrous destruction can be minimized to some extent.

Apart from the unpredictable disasters like earth-quake, pro-active measures and preparedness can lessen the disastrous situation. For instance, the heatwave is expected around the months of April - July, similarly monsoon is expected from June - September in almost every region of Pakistan. Thus, installing shades for heat, making barriers for floods and evacuation of people can help to address

In such situation, it is important to not let them settle there in the first place. Private-housing enterprises must be held accountable, legal actions must be taken against them to set the precedents for the other encroachment base housing entities.
