2.1) Shah Waliullah's Role in Socio-political awakening

He translated Quran from Arabic to Persian to make it accessible for nobles, and condemned sectarianism and social evils. He also linked religious revival with political ~~stability~~ ~~stability~~. He identified the key ~~threats~~ ~~threats~~ to political survival of Muslims in India and wrote letters to nobles to fight against Marathas. Moreover, his efforts led to Third Battle of Panipat and this victory provided reprieve for Muslim rule in Delhi.

2.2) Sir Syed's Role in Socio-political awakening

He recognized educational backwardness as a root of Muslim decline. So, he launched the Aligarh Movement and founded MAO college (1875) to encourage nationalism and modern ~~learning~~ ~~learning~~ side by side along with Islam. Also, he was the one who introduced the idea of Muslim political distinctness in India.
