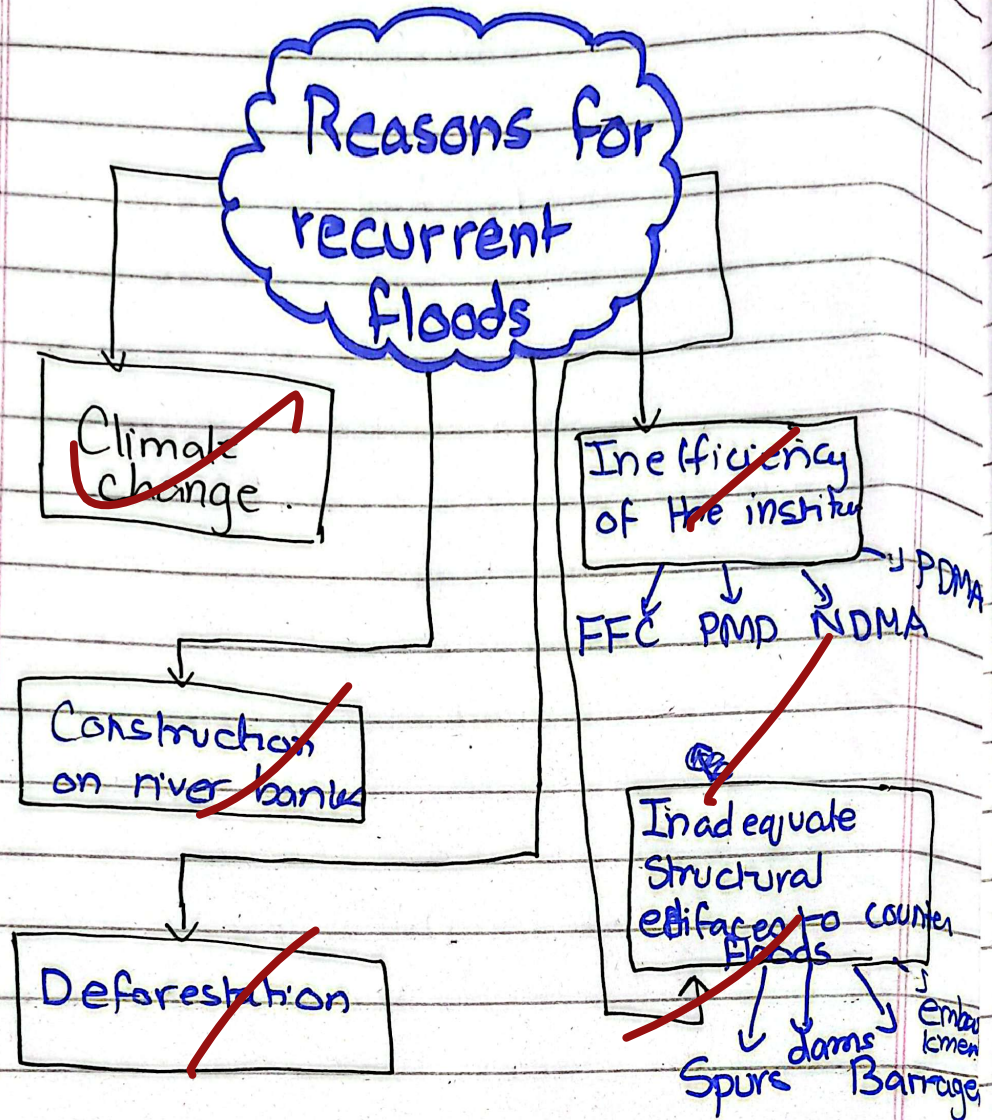
1) INTRODUCTION

a) Climate Change: major reasons for floods in Pakistan.

to control the floods.

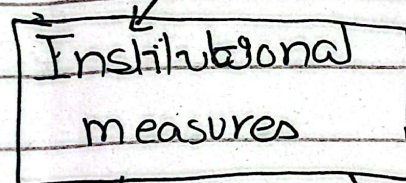
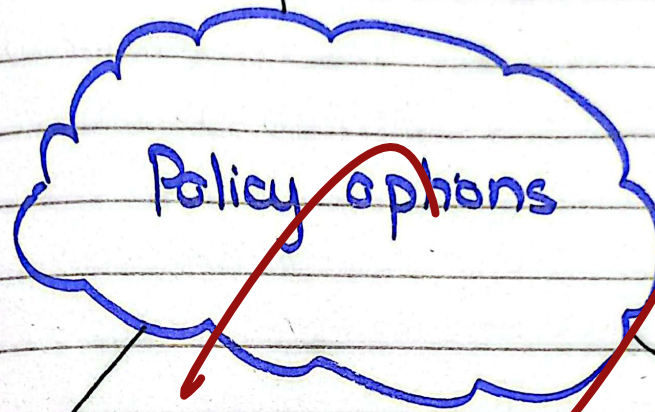
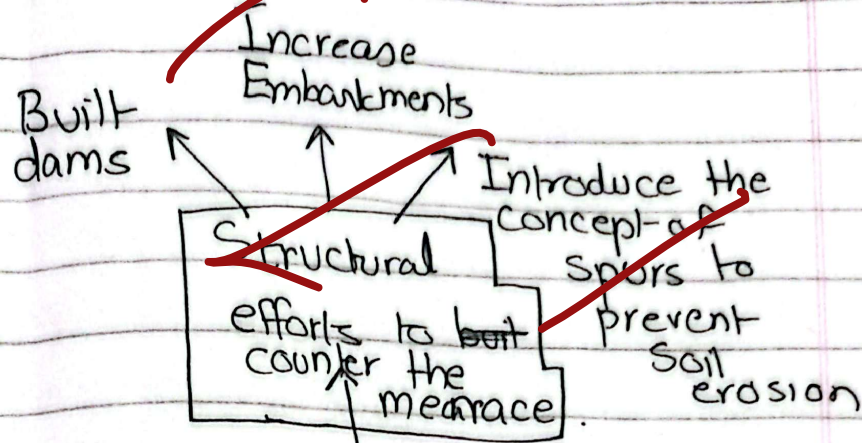
d) Deforestation: leading to riverine

Construction on riversides.

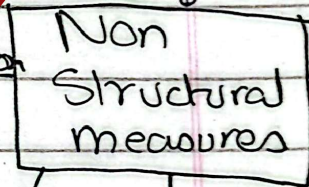
After the deforestation

3.1) Institutional measures

a) Increase the efficiency of the ~~between~~ institutions.

The institutions must be capable enough to detect the early occurrence of flood and take pre-emptive measures. Increase the number of employees and enhance the capacity training of all the workers to counter the menace and destructions caused by the floods.

b) Increase the co-ordination between institutions.

There should be an increased coordination among the institutions such as Pakistan Meteorological Department and NDMA along with PDMA. The PMD should detect the increased changing weather patterns and inform the PDMA and NDMA to take effective steps to counter the destructions of the natural disaster.

3.2) Structural measures to reduce the destruction caused by floods.

Along with the institutions

The government of Pakistan should invest to improve the structures responsible to store excessive water and prevent the overflowing of rivers.

a) Build dams to store excessive water.

The government must build dams on the intention to store excessive flow of water during floods, as a priority.

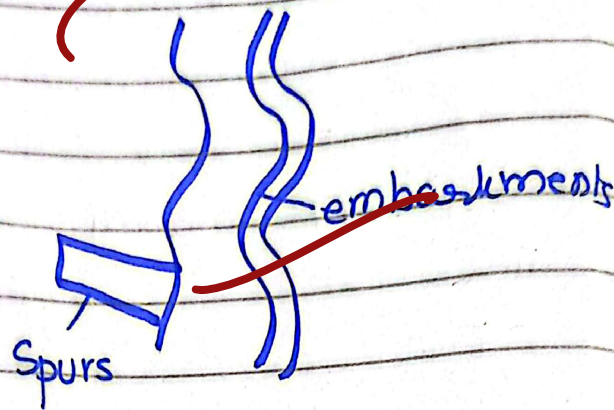
b) Increase embankments to stop the rivers from overflowing.

1) INTRODUCTION

Hydropolitics is very popular topic in South Asia as water is essential for the existence and sustenance of life. Due to climate change the water is becoming scarce in comparison to the ability of the nations. In South Asia many countries share water that runs along more than one country. 2) Hydropolitics in the region between India, Pakistan and China.

a) India and Pakistan : The abeyance of ^{IWT} India from IWT by India.

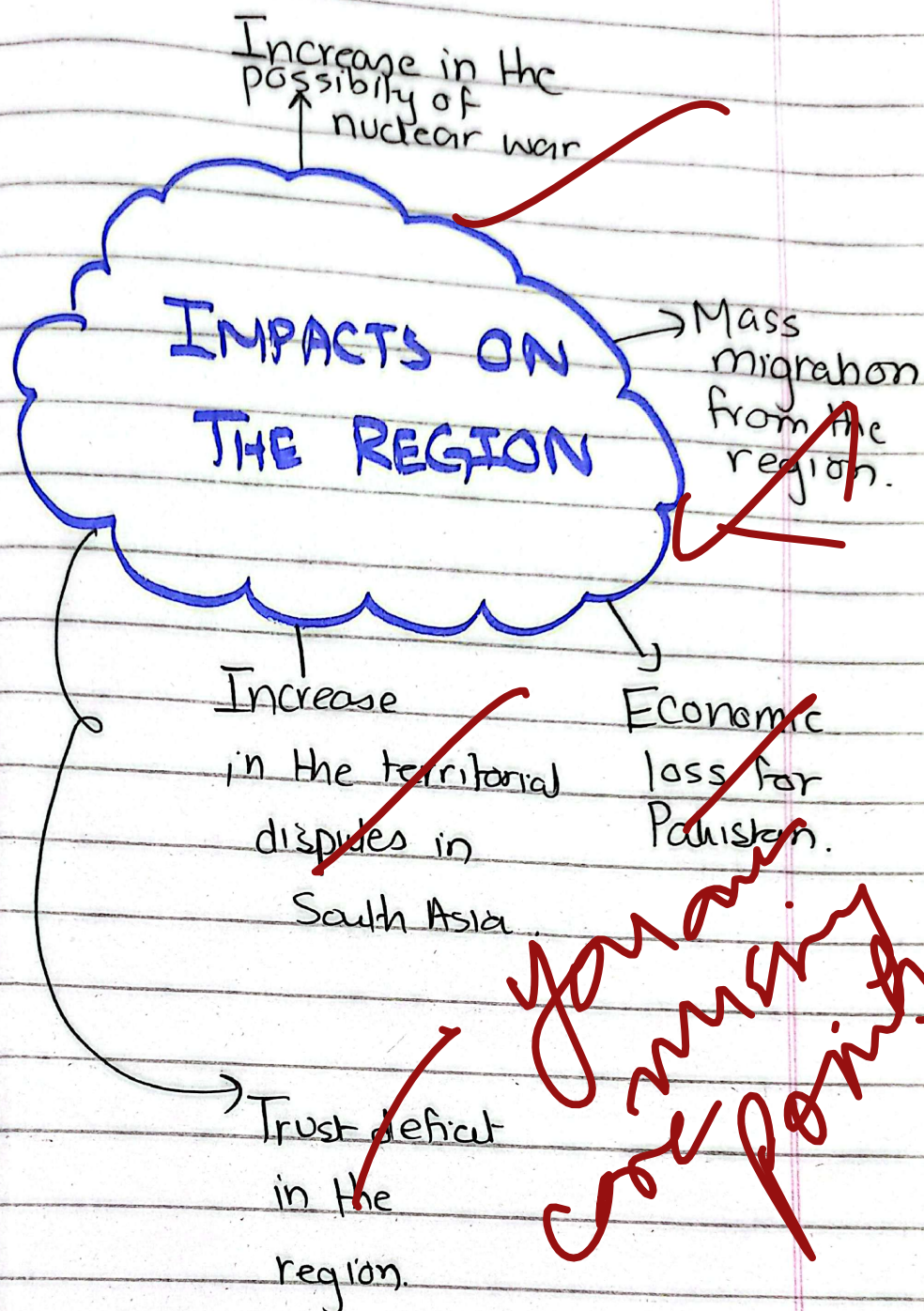
Between the two countries India is an upper riparian. After the Pahalgarh India has unilaterally revoked the IWT. This allows India to utilise water according to its own will, including storage for

water by building dams and increasing the domestic use for urban areas and irrigation.

b) Between China and India:
Dams on Brahmaputra by China.

China is the upper riparian and India is the lower riparian. Since India revoked the treaty, China has sped up the building of five dams called the Motou hydropower project on the Tsangpo river which enters India through Brahmaputra river. The Chinese government has called it the dam of the century as it is the biggest project in the world and give China a hold on the water politics of the region. Since Pakistan is a proponent of China, Beijing is using its capabilities to pressurise India and containing it from gaining hegemony in the region.

3) IMPACTS ON THE REGION



a) Increasing possibility of a nuclear war between Pakistan and India.

Pakistan and India are

nuclear countries. According to the doctrine of Pakistan, water is an existential crisis for Pakistan because it is highly dependant on the Indus river for domestic purposes and agriculture. If India stops the flow of waters to Pakistan, then Islamabad will utilise its nuclear doctrine and conduct nuclear strikes on India. Consequently India will retaliate and this will cause mass destruction in the region.

b) Mass migration from the region: devastating effects of nuclear war and the existential crises for Pakistan.

By revoking the IWT, India will stop the water of Indus from entering into Pakistan. The population will see no sustenance in the country and will shift to the western countries. Moreover, the devastating effect of nuclear war will make the two countries

inhabitable. So, the people of both the countries will prefer to move out of the region before it is too late.

c) Economic loss for Pakistan.

Since Pakistan has an agrarian economy, it is heavily dependant on the Indus river for the agriculture. The decline in the river flow will result in ~~the~~ a huge economic loss for Pakistan.

d) Increase in the territorial disputes in the regions.

India has disputes with Bangladesh, Nepal and China regarding the sharing of water. Since India has walked out of the IWT, there is a growing concern in the other regions ~~like~~ that are at the lower riparian that India will do the same to them. Moreover, India is funding a dam in Afghanistan on river Kabul that

put further strain on Pakistan.
All of this will result in the
surge in territorial disputes in the
region.

c) Trust deficit in the regional
and international institutions

Since the World bank and
BRICS are unable to prevent
India and China from preventing
violating the international law,
a trust deficit has been increasing
on the international and regional
institutions among the South
Asian countries.
