Churchill referred to this as the 'worst best decision' that he had ever made, highlighting the pressure that comes with dominion.

was produced in the aftermath of this recent disaster increasingly highlighted the failure of authorities, especially provincial governments for poor housing planning and their lack of efficiency in governing the illegal settlements of buildings, businesses and houses on the riverbanks - which was pointed out as the main cause of the widespread destruction ~~as~~ opposed to the record-high rainfalls as a result of climate change. This instance shows how the policy maker and the burden of decision-making acts as a huge weight on them and tests them.

The eminent individuals delegated with the authority to administer justice tread a very thin line between maintaining ~~their~~ moral values and moral responsibility and sustaining their power. It is indeed a delicate position to hold, balancing the scales of justice while ensuring the stability of power. In theory, law is impartial but sometimes, the judges are often faced with situations where legal decisions intersect with complex moral dilemmas.

For example in a historic case of **ROV**, **Dudley and Stephens (1804)**, the judiciary had to balance legal principles of murder with a moral dilemma: whether it was justifiable for the shipwrecked sailors to kill and eat a fellow survivor in order to survive. Eventually, the court ruled in the favour of the murdered survivor, iterating that necessity is no solid defense to ~~murder~~ kill a person even if it puts one's survival at stake. Such instances signify the burdens that befall those who wield authority while making an effort to maintain their integrity.

The family is the basic structural and functional unit of a society that ultimately acts as a decisive factor in shaping that society and by extension, the nation. The role of parents in determining the values, ethics, traditions, ~~culturing~~, and educating the children is monumental.
