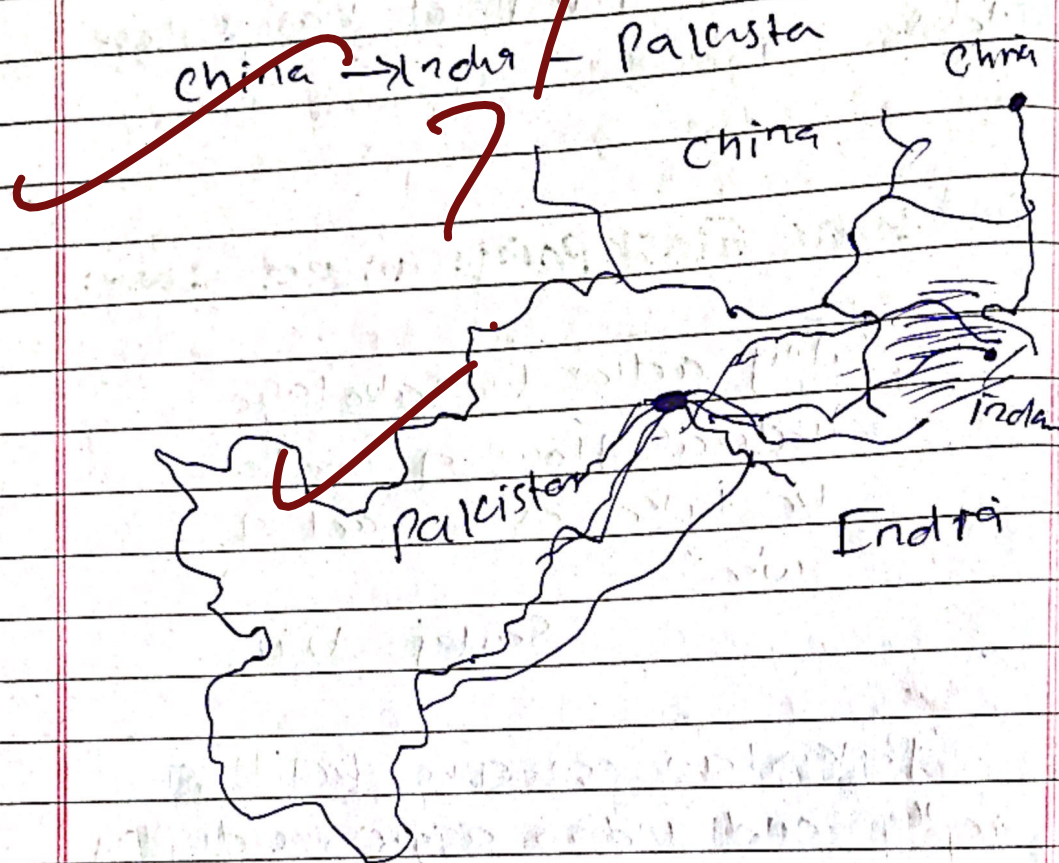
Repercussions for South Asia

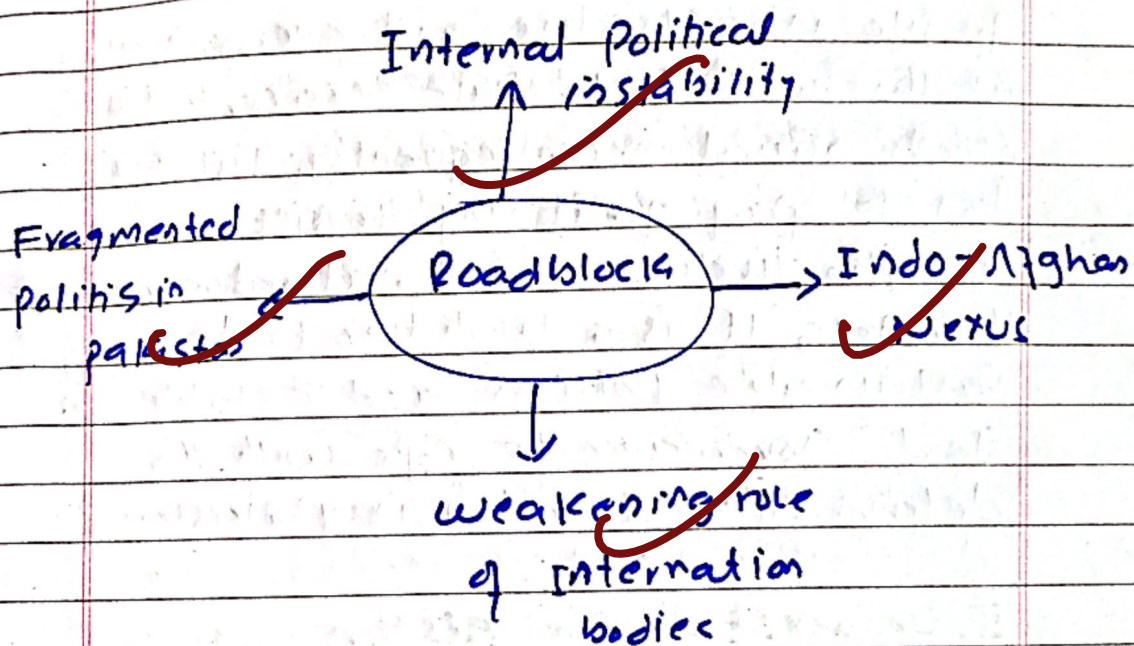
Indus originates from Tibetan region of China and crosses Indian illegal occupied Jammu and Kashmir to Pakistan.

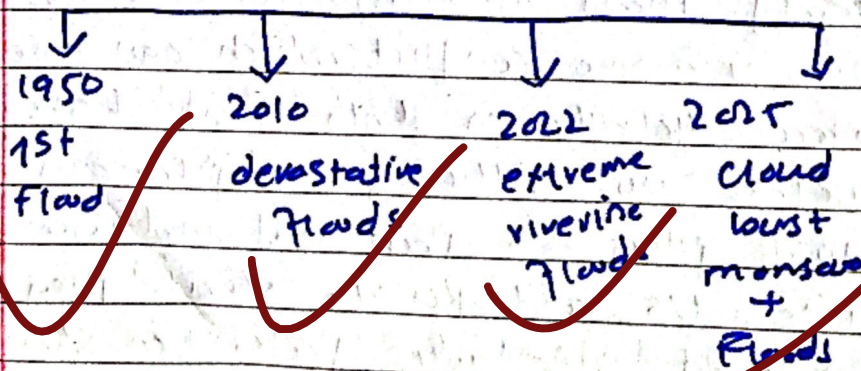
