Pakistan's about less than 1% involvement in Global Climate Change Effect but the most effective damage has been bearing due to climate. One of the major reason is two massive fossil fuels or non-renewable energy emitters are its neighbours of Pakistan. Moreover, Pakistan is also shifting towards renewable energy due to its geographical location better for solar and hydrological processes. Pakistan faced lot of disaster challenges from lack of effective policies to unawareness of people about the reasons and upshot of climate changes. Then, Pakistan is wanted to enforce policies under specific domains organizations like Natural Disaster Management (NDMA). Along this, by the development of effective policies, government should vigilant it must not get influence of feudal lords.
