According the Climate Disaster and its impacts on young girls report (July 2025),

climate brides is a concept practiced in parts of Sindh and ~~the~~ Southern Punjab where young girls are married off against their will to ease their responsibility as parents. Thus climate change is the cause of crime such as early marriage and forced marriages in Pakistan.

One more reason for forced marriage is parents responsibility of marriage. Parents are required to fulfill this responsibility in a Pakistani society. To fulfill this responsibility, parents often use their authority to set any match for their children. Children ~~are~~ often not allowed to express their will. This gives parents a free hand for playing with future. According to a Muslim scholar, Nouman Ali Khan, parents ~~in~~ South Asia waste their children's potential and brilliance by forcing or pressurizing them into marriages they don't assent to. This leaves the children in no way capable for progress of themselves and of their marriages. Hence, parental responsibility is one of the

main causes of forced child marriages.

Subsequently, an important and often neglected cause of repeated forced marriages in Pakistan is lack of functioning and vigilant authority. Government authorities have paid a deaf ear to the matters that are associated with family.

The state often lacks rules on forced marriages and the ones that are present are often overlooked. Government have little intervention in forced marriage crimes which has left the situation

unbridled. Quick and easy access to family laws and nuptial ~~and~~ rules and regulations can put a stop to the situation. This is an evidence to the fact that forced marriages are often exacerbated by lack of rules and regulations.
