1. INTRODUCTION

Pakistan faces a ^{small-} ~~small~~ state dilemma amid the intensifying US-China rivalry. While it enjoys strategic partnership with China rooted in the China-Pakistan Economic Corridor (CPEC) and defense cooperation, it also sought to revive ties with Washington through renewed diplomatic, security and economic engagement. As Noor Yusuf noted, "Pakistan cannot afford to side with one pole in a polarized international order." In order to

preserve its autonomy and national interests, Islamabad must adopt a calibrated multi-track policy anchored in diversification, compartmentalisation, transparency and domestic resilience. This means Pakistan should deepen its economic ties with China without isolating itself from the western led global order, and strengthening its internal economic and governance structure to reduce external dependency. Pakistan's foreign policy trajectory reflects a long history of navigating between global powers to ensure

its strategic and economic interests.

US-Pakistan Relationship: History Full of Transactional Cycles

The US-Pakistan relationship has long been characterized by transactional cycles - phases of **intense cooperation** followed by **period of mistrust**. During Cold War, Pakistan aligned itself with Western alliances, viewing them as instruments to counterbalance India and ensuring military and economic assistance. It became a crucial partner in **Afghan Jihad** supporting US effort to counter **Soviet Invasion of Afghanistan**. Pakistan-China relations have historically been marked by consistency and strategic depth also recalled by "higher than Himalayas, deeper than the oceans, sweeter than

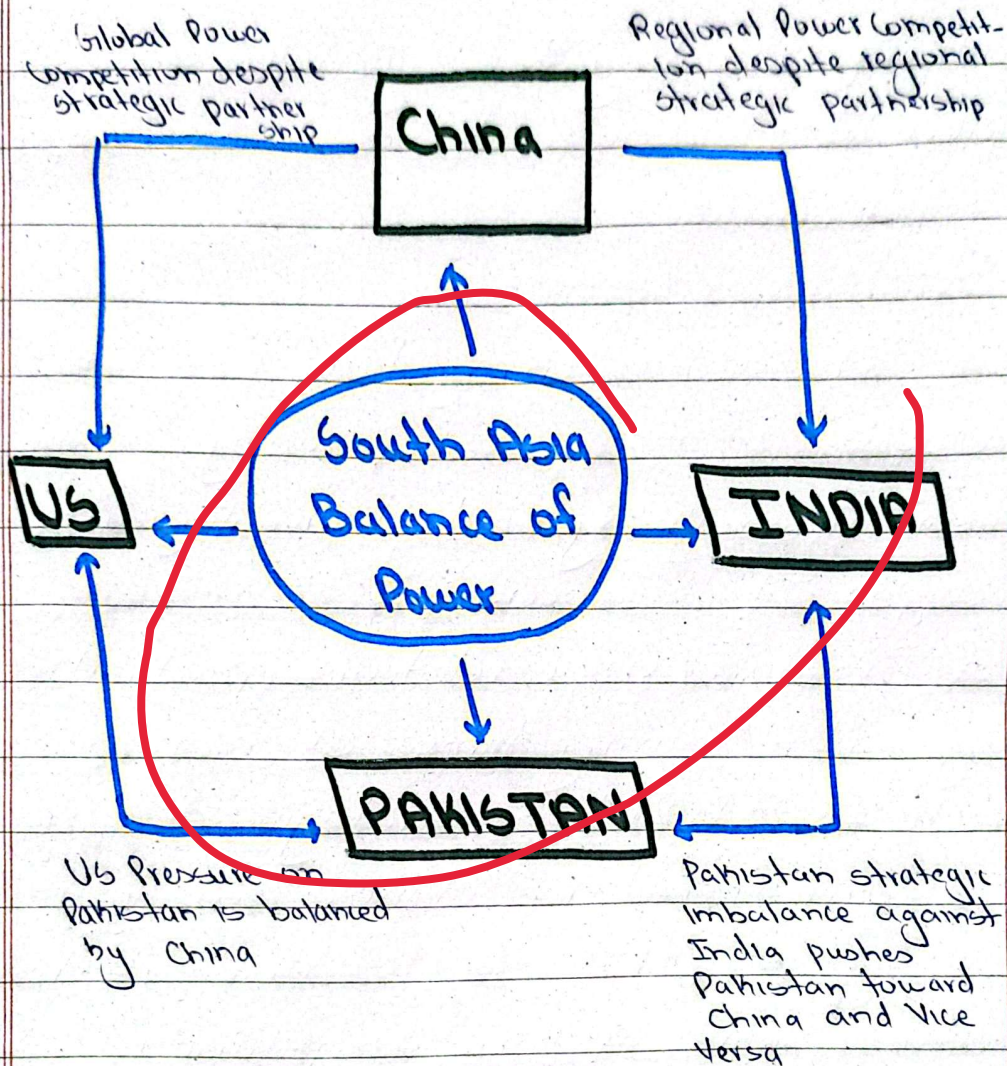
"honey," reflecting the symbolic and practical closeness of the partnership.

Strategic Partnership

China has emerged as Pakistan's closest **strategic ally**, providing sustained economic, military and technological support. It has been a **cornerstone** of Pakistan-China relations, particularly evident during times of **regional tensions**. Pakistan's strategic **deterrence** is strengthened by Chinese supply of **fighter jets, missiles** and other defense hardware. The longstanding **JF-17 fighter jet program** exemplifies sustained joint defence development.

As **Michael Kugelman** noted, "**China remains Pakistan's principal military anchor, ensuring Islamabad retains strategic autonomy in the South Asia.**"



Economic Partnership

CPEC promises investment of **62 billion dollars** in Pakistan. CPEC is central to Pakistan's infrastructure and economic development. In addition to this, **70% of Pakistan's FDI** originates from China. In the fiscal year **2024-25**, China's net FDI in Pakistan soared by **90.4%**, reaching **\$12 billion** up from **\$643.2 million** in the previous

year. China stands as Pakistan's **largest trading partner**. In 2024, the total bilateral trade in goods reached **\$23.1 billion**.

Diplomatic Support

Throughout history, China repeatedly used UNSC veto in Pakistan's favour. For instance, in **1998** after **Chagai Nuclear Test** and in **2019** when India revoked **article 370**.

4. BALANCING BOTH POWERS

Pakistan historically demonstrated skills in managing relations between major powers, often leveraging ties. As during Afghan Jihad Pakistan maintained strong ties with both countries, ensuring a strategic hedge. Similarly, during the War on Terror, Pakistan collaborated with US on counter terrorism efforts and continued ensuring Chinese economic deals. Pakistan needs to balance as no single partner can

deliver all Pakistan's needs. In this multipolar world, there is a cost of choosing as picking one camp risks sanctions, lost market access.

Use of Joseph Nye's Smart Power Framework

Pakistan needs to use Joseph Nye's smart power framework in which it will combine its hard and soft tools to widen options. Pakistan should cooperate with each power where interests converge.

Vendor Diversity

Pakistan must diversify its market to avoid single-vendor dilemma.

This will help Pakistan maintain autonomy in economy.

Multilateral Platforms

Pakistan must prefer engaging through multilateral institutions than unilateral engagements.

Military Policy

Pakistan should maintain targeted and limited military cooperation and avoid all-out alliance with either power. However, Pakistan must adopt **No more boots on the ground policy** against US military presence.

Prioritize Domestic and Security Stability.

Machiavelli once said, "One should never fall in belief that you can find some to pick you up." This quote underscore the importance that Pakistan must strengthen its internal political and economic institutions to avoid reliance on foreign powers.

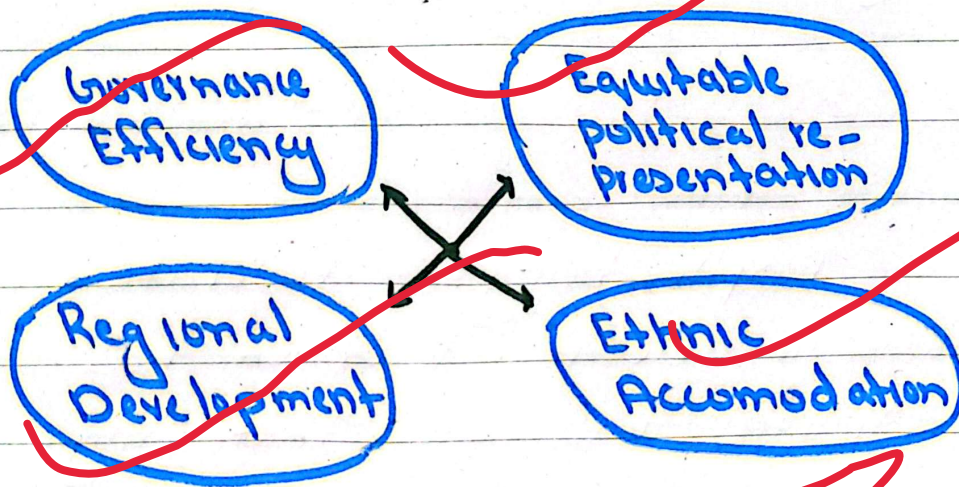
2. DISCUSSION OF CREATION OF NEW PROVINCES

Despite being a federation, Pakistan since its inception has a centralized governance that only impact its national solidarity but also causes grievances among many marginalized communities. Due to this, Pakistan has seen debates around the formation of new provinces over the years. This debate demands new provinces in Punjab, Hazara and Urban Sindh. Recently, the renewed media interest called for 12 provinces. These demands can put efficiency, political stability

national unity and economic sustainability at stake.

3. ARGUMENTS PRESENTED BY SUPPORTERS

Supporters of this discourse cite several reasons



• Governance Efficiency

Larger provinces like Balochistan and Punjab has vast area that cause administrative services difficult. For many administrative tasks, citizens have to travel to the administrative capitals. Smaller provinces can improve response.

• Equitable Representation

Federal decision making is

influenced by representation in National Assembly. As Punjab account 56% of population, it creates an image of Punjab's dominance, however, this can be maintained by equal representation.

• Regional Development

Many far flung districts lag behind in basic facilities. Making new provinces will increase investment for these areas.

• Ethnic Accomodation

Subethnic groups (Hindko, Seraiki, and Muhajir) occasionally demand recognition. Creating new provinces will symbolically acknowledge their identity and reduce alienation.

4. ASSOCIATED RISKS IN CREATION OF NEW PROVINCES

1. Constitutional and Legal Challenges

Article 4 and Article 239 of the constitution requires a two-thirds majority in both national

and provincial assemblies to amend boundaries. Achieving political consensus is difficult due to divergent interests of existing provincial governments.

2. Ethnic and Political Consensus

Drawing new boundaries in a diverse area can cause tensions due to ethnic and linguistic sensitivities. Political parties can exploit this issue based on electoral calculations by promising new provinces. This can result in parliamentary deadlock, street agitation and further polarization.

3. Economic and Resource Distribution Lens

New provinces will require new assemblies, high courts, secretariats, and ministries. This would require billions in annual expenditures. Pakistan is already suffering from

fiscal deficits. This could lead to disputes over revenue sharing, natural resources and taxation. Besides this, small provinces may struggle with **self sufficiency** without central support.

4. Intra Regional Inequalities

Creation of new provinces can empower dominant groups such as **Serahi speakers** in South Punjab. It will create further division as minorities will remain underrepresented.

5. Security and Governance Issue

Creating new provinces can lead to administrative disruption and governance vacuums in the short term. There is potential for legal disputes over boundaries that can paralyze governance for years.

5. RECOMMENDATIONS FOR SMOOTH FORMATION OF NEW PROVINCES

1. Constitutional and Legal Framework

Amendment of constitution will be required for clear, detailed procedure of provincial creation. There is a need of transparent legal framework to **avoid litigation and disputes**. Involvement of **independent constitutional experts** and the **Council of Common Interests** will be crucial.

2. Inclusive Political Dialogue

There is a need for engagement of all political parties, provincial governments, and local stakeholders. Public consultation and referendums must be conducted in areas demanding provincial status. There must be guarantee that all decisions will be taken on the base of **national interests** rather than

short-term political goals.

3. Economic Planning and Resource Allocation

A detail economic plan must be devised for each province which will include budgets, infrastructure, and revenue sharing mechanism. Hasty reforms must be avoided; central government must prioritise economic recovery and stability. Private investment and developmental projects must be encourage to enhance self sufficiency

4. Security and Administrative Measures

Gradual reorganization of civil administration, police and governance structure will help implementation of conflict-resolution mechanism to handle boundary disputes. During transition, in order to establish law and order and prevent unrest

government must devise conflict resolution plan in advance.

6. CONCLUSION

The formation of new provinces offers opportunities for better governance, resource distribution, and recognition of regional identities. However, it faces multifaceted hurdles including constitutional, political, economic and social challenges.

A successful approach requires clear legal frameworks, inclusive dialogues, economic planning and attention to social cohesion. By adopting a phased and transparent strategy Pakistan can address local grievances, strengthen democratic governance and maintain national unity while accommodating the aspirations of its diverse population.

3. CAUSES OF AGREEMENT

1. History of Strategic Relations between Two Countries

Pakistan's armed forces take active role in defending Haram Sharif. Similarly during Arab Israel war (1967-1973) Pakistan's armed and air force actively participated and engaged in dog fights with Israel. Now over 15000 to 20000 Pakistan's troops are already deployed in KSA. This agreement is called the

formal binding of the agreement

2. Dwindling Trust in US Security Guarantees

Over decades, US has gained dollars in billions from Gulf countries in view of security guarantees. However, recent attack on Qatar gave **strong realization** to Middle East. Qatar has aided US in Doha Talks, provide its good offices for Iran/US talks and opened doors for Israel and Hamas talks. However, attack on Qatar make middle East suspicious of US deception.

3. Israel Acting as Aggressor of the Region
