Nevertheless, the war would have to end on

negotiation and assurance of security guarantees on both sides.

Russia's Invasion of Ukraine

Russia invaded Ukraine from three fronts: Donbas region; Crimea; and Belarus.



Reasons behind Russian invasion

1- NATO and EU membership

Russian invasion was instigated by the EU invitation to Ukraine to join NATO and EU.

2- Rare Earth Minerals

Ukraine region has more earth minerals. Among them, rare-earth-minerals were required for

EU green transition.

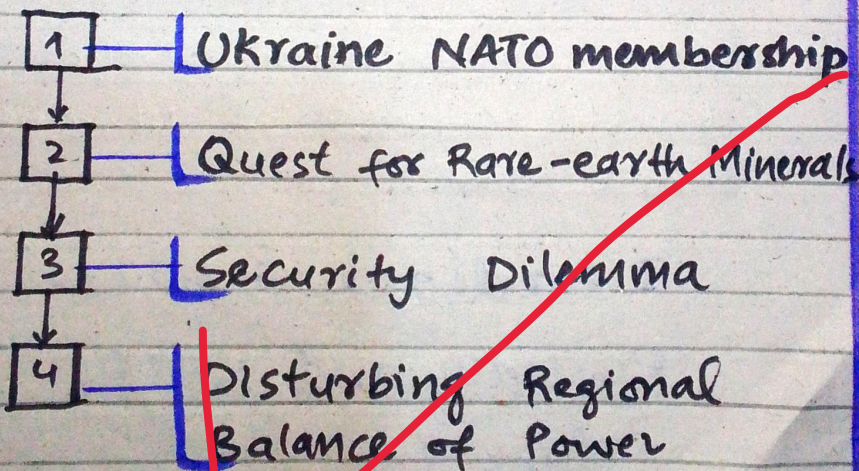
Security Dilemma

Securitization of Ukraine was perceived threat by Russia, fearing the NATO and EU expansion into Russian orbit.

Balance of Power

Ukraine inclusion into EU or NATO could encourage more states to get out of Russian influence, making Russia obsolete in geopolitical architecture of Europe.

Russian Demands

- ① Russia demands neutralization of Ukraine as Buffer State.
- ② Russia wants permanent end to EU instigation.
- ③ No military support to Ukraine from West

NATO Demands

- ① Ukraine Security guarantee
- ② Defending sovereignty of Ukraine; it means to keep Ukraine sovereign so it could freely join any organization.
- ③ Russian intervention in the domestic affairs of Ukraine should end.

Pakistan and Saudi Arabia have institutionalized the informal security guarantees. The Pact has not only refrain south asian aggression against Pakistan, but it would benefit Saudi Arabia too. On one hand, it manifests the mutual trust based on identity, on the other it shows the institutionalization of cooperation. Additionally, the pact was signed when Israel attacked Dina, thus the concept of strategic and security umbrella was formally materialized. However, ~~the~~ Pakistan's involvement in the Middle Eastern conflict would drag multiple question along itself. Thus, the risk of deteriorating diplomatic relations with Iran is not out of question; because, Iran support Houthis. Pakistan Parliament had voted against any military involvement in Yemen in 2015. Pak-Saudi Defense Pact

Causes of SMDA

Kashmir Issue

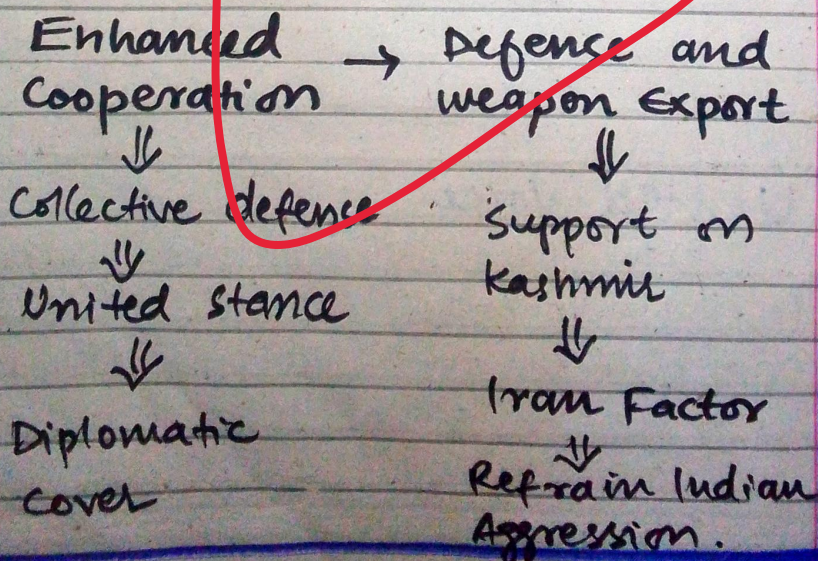

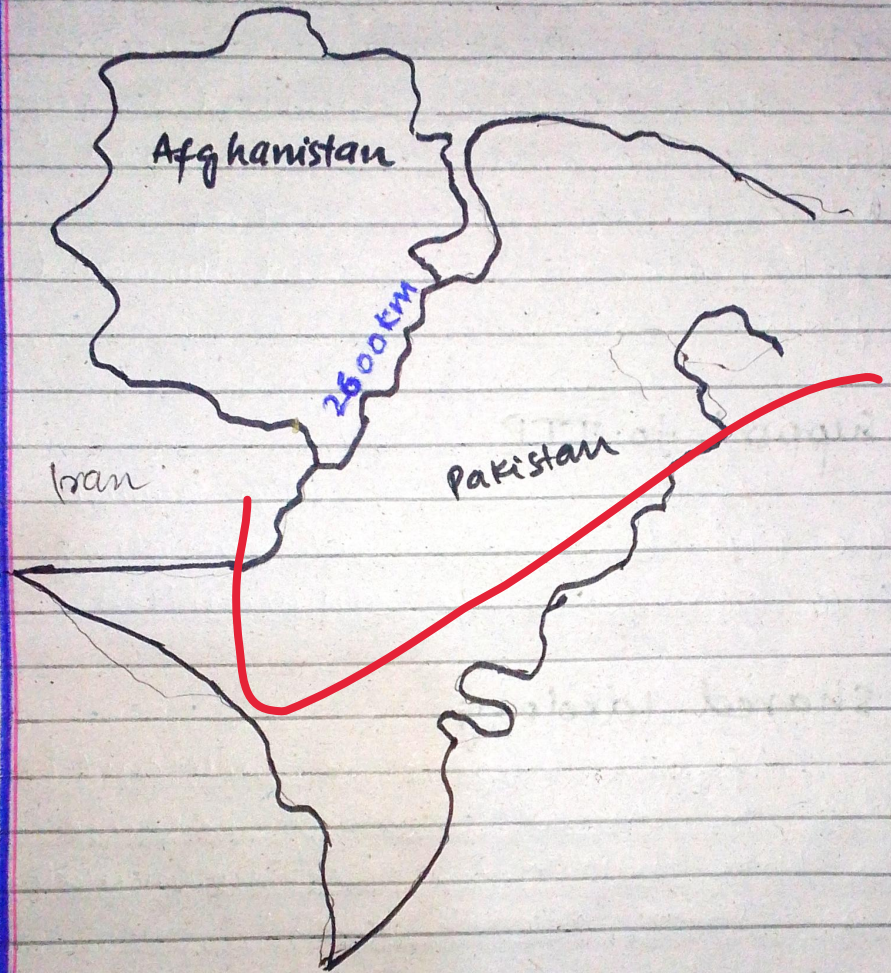

INTRODUCTION

Pakistan and Afghanistan share a history of long hatred and controversy due to duran line boundary. The 9/11, further distanced these two, due to Pakistan's support to the U.S, as per the UN resolution 1386 which authorized ISF forces to restore peace. In such a situation, Pakistan supported Afghan people on its soil while also providing them military support. This angered the far-right nationalist wing and supported Indian security apparatus against Pakistan. Recent border conflicts shows, The TTP reluctance to act against terrorist actors. In this way, they support and host TTP leadership due to shared ideology, cultural affinity, and as a security apparatus to keep themselves relevant in the regional politics. In the meantime, kinetic actions from Pakistan highlighted two important things: Pakistan's intervention; and Afghan leadership evasion of responsibility. Therefore a cross-border fire ended with

Qatar mediation, along with Turkey.

② Support to TTP

Titnath Hindustan is faction used from Afghan soil by India against Pakistan.

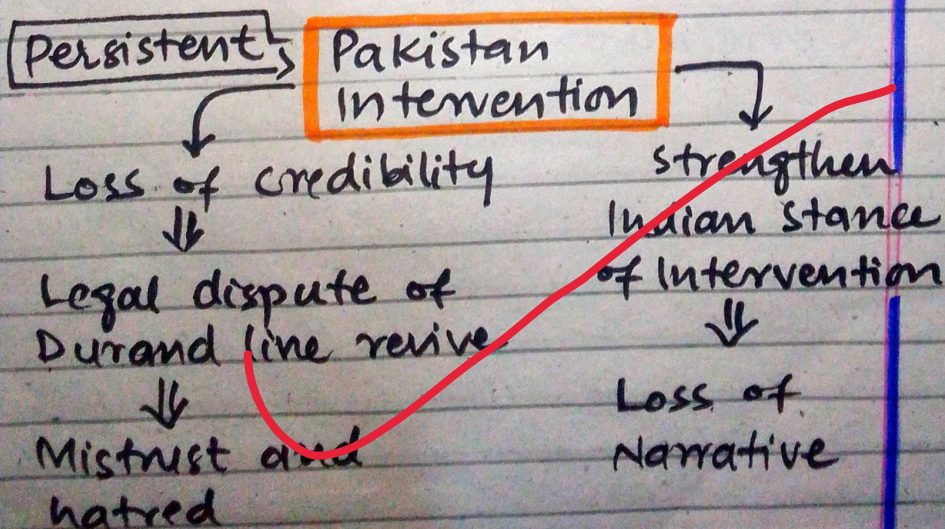
Chinese Factor
