Historical context of economy:

Falctuating structure of political parties, interest groups, and involvement of non-democratic entities was at peak since the inception of Pakistan in 1947. Industrial sector remained in

India and Pakistan still today did not get equal share of financial assets which was meant to be divided fairly. Bureaucrats due to better facilities and strong institutes shifted from the Pakistan to India. India got freedom but Pakistan was created. It's base from the initial point enervated poorly by non-democratic entities and formed a over-developed state structure.

Economic challenges of Pakistan

1) Agricultural stagnation

Pakistan geography is vulnerable to the rapid climate changes and it witnessed many devastating deluges and earthquakes also. Recent flood in June 2025 diminished the soil capacity at many areas to able to grow a resilient crops. It stagnated to 2.2%. Pakistan is mostly agrarian, there is need to

2) Informal economy

The major problem being faced by the economical sector of Pakistan is mostly its undocumented and informal economy that often goes unreported and unregistered.

Almost this informal economy according to one survey contributes to the 65% of GDP.

3) Poor Governance

Pakistan governance is facing many loopholes and flaws just due to the interest of democratic entities and their interest. Government inefficiency is huge setback to Pak economy. Pakistan stands at 133th rank out of the total 180th countries on the transparency corruption perception index.

4) Declining Exports

Pakistan exports are declining at vast level and this creating a fiscal deficit or trade

deficit also. Recently, 30.9 Bn dollars decline in exports is major setback to the economy of Pakistan.

5) Chronic fiscal deficit

When the expenditure and revenue become imbalance, this creates a fiscal deficit. Pakistan is facing chronic fiscal deficit in 2024 it reached over the 7.4%.

6) Energy crises

Pakistan having the widened circular debt that causing the huge crises in the energy sector. It provides 2.7 tm subsidies to the power sector and 1.6 tm to the gas sector. It actually hinders the growth of energy sector.

7) Industrial slow down

Industries facing backlash and investors have the fear to invest due to the instability and current conditions of Pakistan. Pakistan exports indirectly depend on imports because material to

prepare for the exports are actually imported ones that later prepared.

The Road Ahead

Below mentioned are major policy recommendations to the current challenges to the economy of Pakistan.

1) From agrarian to industrial shift

Developed countries always progress on the base of its industrial capacity and technological advancements. No doubt from the very start Pakistan's economy based on the only agrarian sector but now there is need to advance the industrial sector.

2) Good governance is a way to progress

Historical background:

Dynamics of Pak-US relations.

Historical context of Pak-US:

Pak-US ties was not a stable one relation since the inception of Pakistan in 1947. Pakistan always supported the interests of US such as in the 9/11 attacks, and when ~~the~~ Soviet invaded the Afghanistan. Shift after the new government:

Role of Key political and social ideologies in Pak-movement between 1930 to 1947.

Introduction:

Muslims under the dominance of Hindus in sub-continent was so bad and tragic but the two nation theory and muslim nationalism provoked a sense of separate homeland or sovereign state.

Two Nation theory:

1. Role of Sir Syed Ahmad

The two nation theory was actually embedded in the writings of the Sir Syed Ahmad Khan. He understood the atrocities and the difficulties faced by the Muslims so he urged them to unite for the demand of sovereign state.

2. Response to Hindu Dominance

Hindus were in the good books of British at that time and Muslims were like a minority. They were like slaves but at that time some ideologists played an immense role.

3. Ideological Justification

Later on, Quaid-e-Azam Muhammad Ali Jinnah adopted the two nation theory and he provided the ideological justification for the creation of Pakistan because it was not possible for both different nations to live on one land.

Muslim Nationalism

1. Islamic identity

Muslims having the rich Islamic traditions, culture, and heritage that promoted nationalism for the Muslims of sub-continent.

2. Role of Allama Iqbal

Allama Iqbal through the poetry awakened a muslim nationalism in the Muslims and united Muslims should dissolve ethnic and territorial divisions.

3. Aligarh Movement

Sir Syed Ahmad Khan started Aligarh movement through the education and Islamic teachings and developed leadership qualities in Muslims. It was the birth of Muslim League.

Key Events

→ Allahabad Address (1930)

Allama Iqbal's Allahabad address in 1930 laid the intellectual groundwork. He suggested to amalgamate the Muslim majority areas like Punjab, North-west frontier provinces, Sindh and Balochistan

Into a separate sovereign state.
This key event from the demand of muslim minority rights to the necessity of separate homeland was actually a political thought.

→ Congress Ministries of 1937-39

The conduct of Indian National Congress formed after the provincial elections of 1937 intensified a fear in Muslims of Hindu dominance. There was no right for Muslim League to have the power shares from the Congress of India. It promoted a sense of separatism and Quaid-e-Azam understood that Muslim political destiny needs a viable path separated from the Hindus majority.

→ Lahore Resolution (1940)

Although, it did not name as "Pakistan", it was a clear message to all for the

demand of Independent state. This resolution galvanized Muslim behind a single cause and the need of separate state and forced British and Congress to take the demand seriously. This took a decisive effect and advocated minority safeguards to self-determination fundamentally based on the Two Nation-theory. It changed the political discourse of India.

Conclusion:

The Role of key political and social ideologies in Pakistan Movement between 1930-47 played an immense role. Major events like Allahabad address, congress ministries of 1937-39, and Lahore Resolution of 1940 laid the base for homeland where Muslim majority unites and have the right of self-determination.
