The martial law of 1999 came to an end in 2008 by the introduction of National Reconciliation Ordinance to restore democratic culture in Pakistan. The first fruit of restored democracy, the 18<sup>th</sup> Amendment to the constitution of Pakistan, laid the foundation to shape and secure the future democratic frame work for governance in Pakistan. However facing the worst security challenge, terrorism, of its history Pakistan was unable to achieve its governance objective in the first phase.

The current clashes on boarder, resulted in heavy losses for Taliban, was also mediated by Qatar and Turkey where both countries agreed to not allow militant to operate against the state

In a lesser context the Afghan regime should have proposed a joint mechanism for relocation of these migrants, On the other hand they are challenging Pakistan legal rights to act against those involved in unlawful activities.
