Pakistan Saudi have signed a historic defense pact. Critically evaluate the causes and implications of the deal.

Answer

A- Introduction:

On 17th September 2025 a deal named as Strategic Mutual Defense Agreement (SMDA) was signed between Pakistani Prime Minister Shehbaz Sharif and Saudi crown prince Muhammad bin Salman. The core commitment of defense pact says that "Any act of aggression against one country will be considered an aggression against both." This pact is defensive and does not target any specific state and cover all

military means of both states.

And in principle the details

of pact are still vague.

B. Causes of defense deal

between Pakistan and

KSA:

There are some old

and certain new causes

behind this deal. These

causes include:

1) Immediate need for stronger deterrence in an increasing volatile middle East:

Both countries Especially Saudi needed deterrence against all kinds of aggression in an environment which is volatile. The volatility of middle east is observed as israel has defeat all proxies of iran in the region i.e Hezbollah, Houthi and eventually attacked Qatar after attacking iran. This left KSA very insecure in the region and she gained support from Pakistan.

2. It is proved US will not defend its allies against israel:

After this proval Saudi wanted to expand its defense reliance from US to a trust worthy ally.

3. Strong and Cooperative relations between both countries in defense:

Pakistan has been protecting Haramain Sharfain since 1960's and was training army of KSA also. Years of defense co-operation result in a formal defense deal between two.

4. Pakistan's Strong win in May standoff against India:

The May Standoff has skyrocketed the image of Pakistani military not only within the country but also in the region.

KSA wanted to grab the opportunity and expand its defense by seeking support of a strong army like of Pakistan's.

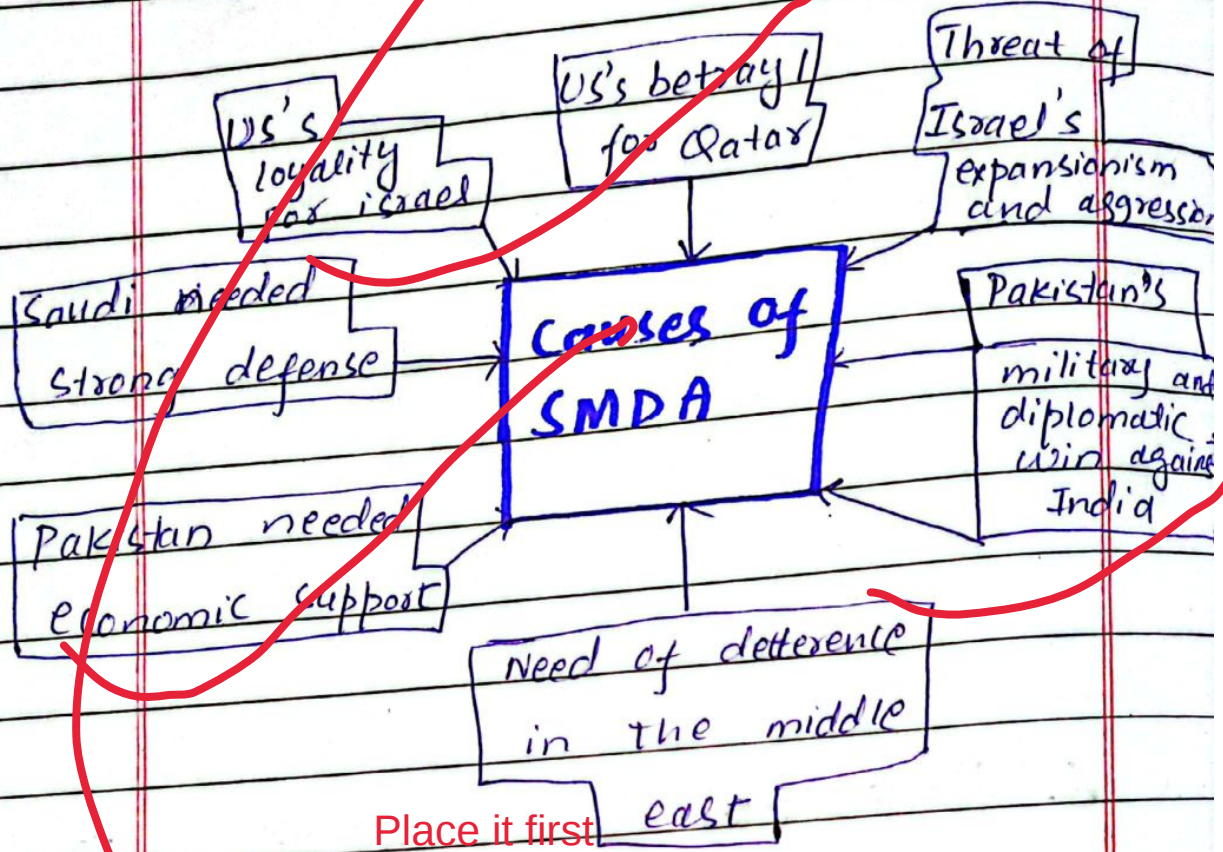
5. Israel's attacks on Qatar, Iran and in the overall region:

Israel has been portraying itself as a rogue state since October 7. Israel has attacked Iran after defeating Iran's proxies and then it attacked Qatar which is a Gulf country led by Saudi. These attacks pushed KSA to sign this deal.

6. Pakistan's economic vulnerability:

Pakistan is facing economic crisis in last few years and she wanted to gain economic benefits from KSA by signing this defense deal with KSA. Pakistan needed economic support and Saudi needed military support, through

this deal both countries
saw their interest and
sealed it.

1. Introduction:

To address this, pragmatic measures are needed.

2- Reasons behind revival of militancy in KP and Balochistan:

There are two School of thoughts about revival of militancy in Balochistan. These are

1- The Centralist School of Thought.

2- The federalist School of thought.

B. Hurdles to the creation of new provinces in Pakistan:

1. Framework of 1973 Constitution has made it difficult:

It requires resolution initiated by respective provincial assembly and it needs $2/3^{\text{rd}}$ majority for favour of resolution from respective provincial assembly. This procedure is given in Article 239-4 of Constitution.

2. Consensus of political parties is difficult:

PML-N has strong support in Punjab and it will never allow its division while PPP will oppose division of Sindh and in the same way PTI in KPK. So political parties consensus

is almost impossible.

3. Huge economic cost:

Huge economic cost for formation of new provinces hinders this discourse because Pakistan is facing economic instability.

4. Emotional attachment of people with existing geographic identity:

People's consensus is also difficult as they are emotionally attached with these borders and ethnic fault lines can also increase.

5. Risk of increasing ethnic Fault lines:

Ethnic fault lines can increase by

has resumed its warm ties
with Afghanistan. **Afghanistan**
Foreign Minister visited
India in Oct 2025 and
India announced to reopen
embassy in Afghanistan.

4. Cross-border Airstrikes and Retaliation:

Oct 2025 airstrikes
by Islamabad on Kabul and
Kabul's retaliation have
further tensed the
relations. TTA responded
by saying that this
will not be unanswered.

5- Afghan Refugee Expulsions:

Since 2023 Pakistan has expelled almost 800,000 Afghan refugees due to economic constraints and security concerns. While Afghanistan considers it human rights violation.

6. Mutual distrust and Governance Gap:

Because of burden of history i.e Pakistan's support for US in war on terror there is a mutual distrust between Kabul and Afghan Islamabad. Governance gap between two is also making their relations further tensed and severe.

Final Recommendations:

1- Resume Bilateral

Negotiations:

Both countries must resume peace and diplomacy with bilateral talks e.g. Doha peace talks happened in 15th Oct 2025 and ceasefire must be permanent.

2- Counter Terrorism

Cooperation:

Afghanistan must cooperate with Pakistan in counter terrorism and Pakistan must not compromise on its security by any ways.
