8- You won't pass the essay if make more than 4-5 grammatical mistakes

9- outlines that are not self explanatory or does not aligned to with the essay statement are liable to mark 0 and the essay would become null and void

10- always try to be relevant to the topic, if even your 1 or 2 arguments are irrelevant, the examiner would not pass your essay.

The comprehensive system of disaster risk management was promulgated in the year 2007, National Disaster Management Authority (NDMA), nearly after 6 decades. The challenges ranging from poor coordination among federal and provincial institutions, lack of early warnings, weak institutions, poor fund allocation and poor implementation. The poor coordination among the federal and provincial institutions is a significant challenge of disaster management in Pakistan. after the 18th amendment the

powers of NDMA has been divided into provincial PDMA, which hinders the role of NDMA. yet no officers has been appointed in several districts. Consequently, diminishes the working of institution and increases the mismanagement and communication problems between federal and provincial institutions. Thus, it is imperative to reform the institutions (NDMA, PDMA).

Another significant challenge of disaster management in Pakistan is lack of early warnings. According to the UNDP, Pakistan lacks integrated early warning mechanism. Moreover, the outdated meteorological infrastructure, poor data-sharing mechanisms, and limited rural outreach makes it difficult to warn communities early. Consequently, delayed evacuations and high casualties.
