Marriage should be a bond of love not a chain of coercion. Once Malala Yousufzai said, ~~no one should~~ **Did not** be forced into a life they did not choose. Pakistan is home to nearly 19 million child brides and forced marriages remain widespread especially in rural areas and minority communities. According to UNICEF, Pakistan is one of the highest ranking countries ~~for~~ : forced marriages. The practice of forced marriages is especially common in rural areas of Pakistan where cultural traditions and poverty drive families to marry off daughters early. The tradition of ~~vani and swara~~ is so common where daughters are seen to be as debt settlers or ~~gaurantee~~ to foster the relations among ~~tribe~~ enemy tribes. These ridiculous practices are due to lack of awareness and illiteracy. Often families don't see forced marriages as a crime or human rights violation so ~~they don't~~ forced marriages are not even reported. Despite legal frameworks, forced marriages persist in Pakistan under the veil of socio-cultural norms, economic constraints and lack of education, **ZEENAT** leading to severe social, economic and psychological consequences.

The causes of forced marriages in Pakistan are multifaceted. Cultural and traditional beliefs play a dominant role. Families often ~~see~~ view marriages as a means to ~~preserve~~ honor. Inter tribal marriages are ~~often prohibited~~, paving the way for forced unions in the name of honor. This practice extends beyond Pakistan's border; for instance, 49% of forced marriages cases in the UK originated from Pakistani community.

In Pakistan, this practice remains ~~alarming~~ prevalent, particularly among women and girls, the consent is not taken serious and marriages are imposed through coercion, threats or deception just to control female autonomy. Because there is a common perception that female can ^{be} easily driven by western concept of marriage in which partner is of their choice. In fact this is not ^{only a} western concept but also an Islamic concept of marriage.

In addition, forced marriages are result of poverty and dowry related practices and even these marriages can be seen as financial transaction or debt.
