In Oct 1999, General Pervez Musharraf declared Martial Law. He started governing the country. His era brought really positive changes contrary to previous military rules. It was an inclusive government on the ground that media developed in his era. Private channels were established and the news channels could express their opinion on policies of government without any hesitation.

full fledged protests throughout the country. Giving in to the pressure, Musharraf resigned in 2001 and Iftikhar Chaudry was restored. This movement gave much boost to the power of judiciary and helped judiciary become independent. During this period several amendments were introduced which further strengthened the judiciary, such as the formation of judicial commission of Pakistan.

The Era of Continued democracy 2008 to 2017:

In 2008, Pakistan Peoples Party came to power. Asif Ali Zardari became the president and Yusuf Raza Gilani was appointed as the prime minister. The (PML-N) PPP government for the first time in history of Pakistan was able to complete its term. In 2008, when this government came to power, the local government system was abolished and the autonomy of provinces transferred back to the provinces.

↳ Ineffective tax system:-
