Further move, Parliament Passed the 27th amendment in November 2025 and again changed the structure and appointment procedure of Judges. Moreover, this amendment modernized the military but Pakistan Judicial system is facing many justice

issues in the country.

What is 26th and 27th amendments in Pakistan Constitution of 1973.

i) **Judicial transfer method changed.**

Before 26th amendment it is the right of high Judges that he/she can demand and wish for posting, but After 27th amendment appointment procedure change and this power taken from Judges and is given to Judicial Commission of Pakistan and Supreme Court Chief Justice of Pakistan.

The appointments of Judges was held by Parliamentary Committee and Judicial Commission of Pakistan. Now, the

(i) Parliamentary Supremacy over Judiciary.

26th and 27th amendment give more power to Parliament and reduced the power of Judiciary, because Parliament shall perform functions in Judicial appointments, accountability and transfers.

(ii) Parliamentary intervention in Judicial matter.

Parliament shall decide the Judges for appointments and transfers. So, Parliament ^{will} intervene in Judicial matter.

(iii) Parliamentary committee supremacy on Judicial Commission of Pakistan.

After Judicial Commission,

list of Judges shall be forwarded to Parliamentary Committee. So, Parliamentary Committee is supreme appointing body of Judges.

(iv) Democratic Power increased

These amendments on one side reduced Judicial Powers but on the other hand democratic Power increased. So, 26th and 27th amendments provide democratic supremacy and Power and reduce Judicial influence and independence.

(v) Parliament takes the Power of *Suo motto* to Supreme Court of Pakistan in 28th amendment.

Parliament took the Judicial Supreme Court of Pakistan for basic right violations cases and made a new Court for specific Constitutional related matter. So, Parliament deprived Supreme Court without *Suo-motto* Power.
