

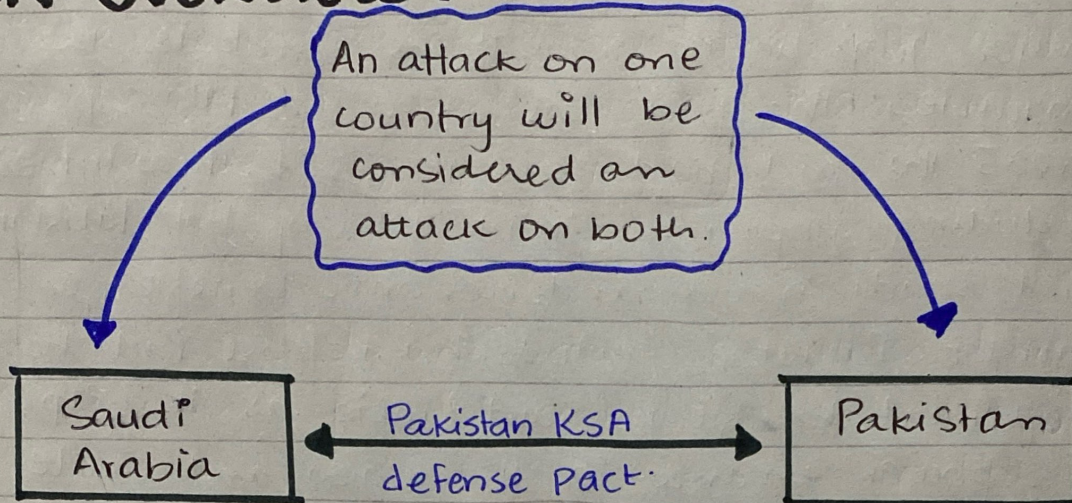
ANSWER # 5

PAKISTAN AS MILITARY LEADER IN THE REGION:

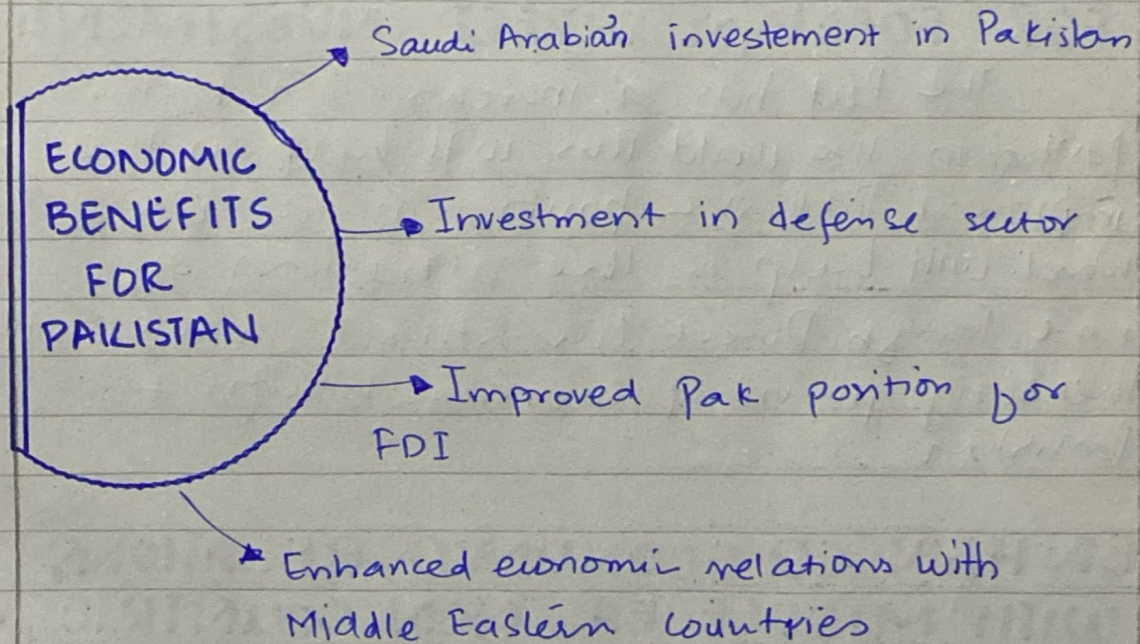
