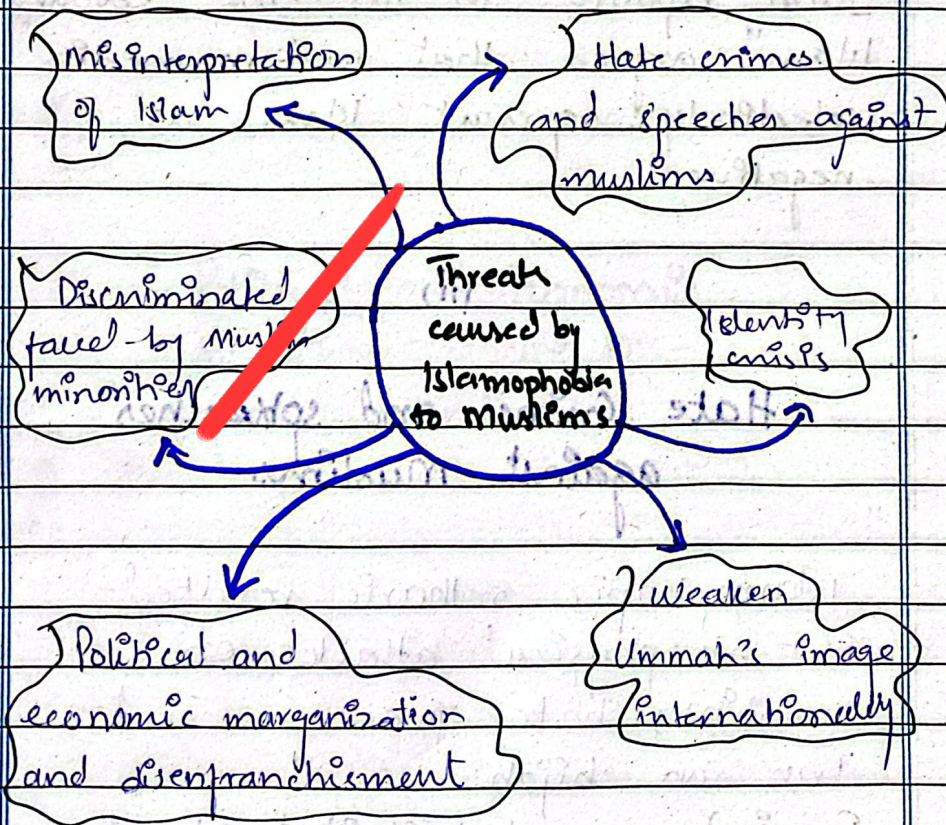

Islamophobia is a threat to Muslim Ummah as it caused several challenges for Muslims. Some of them are:

Misinterpretation of Islam

Islamophobia has caused distorted teaching of Islam. Western Media portray Islam as inherently violent which are against the universal values of Islam i.e. peace, tolerance and compassion. John Esposito in his book "Covering Islam" argued that western media selectively represent Islam as negative.

Hate crimes and speeches against Muslims

Islamophobic rhetoric resulted in physical attacks on muslims, hate speeches and ban on hijab. For instance, in Christchurch in mosque in New Zealand, 51 muslims were killed during Friday prayer by shooting (2019).

Discrimination faced by Muslim minority

Muslim minority faced prejudice in jobs, education, housing and social life because of Islamophobia. Pew Research (2021) reported that 78% of ~~Asian~~ European Muslim feel discriminated because of their faith.

Political and Economic Marginalisation and Disenfranchisement

Islamophobia lead to the political and economic marginalisation of Muslims. Muslims ~~are~~ are considered as "second class citizen" and political parties use Islamophobia to win election.

For example, France ban on Hijab and India's CAA (Citizen Amendment Act) 2019.

Weaken Ummah's Image Internationally

Islamophobia cause damage to soft power of Muslim States. Muslim ban on travel and visa restriction, restricted Muslims from global trade, political participation and academics.

For instance, US "Muslim Ban" in 2017 on Muslim majority countries, stigmatize the whole Ummah.

Constant exposure to rejection, discrimination resulted in depression, anxiety and identity crisis.

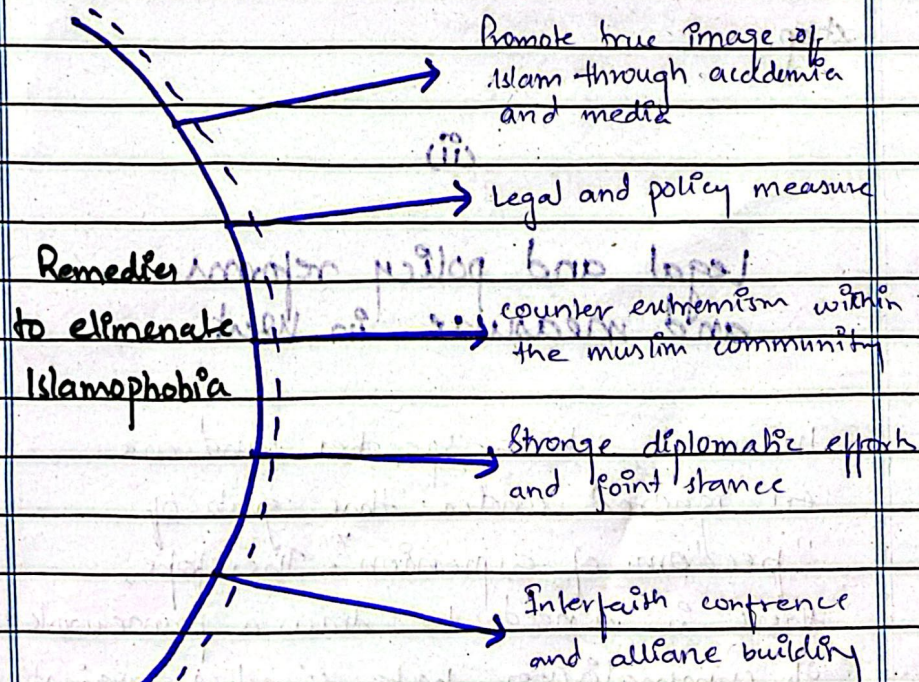
Karen Armstrong in his book Islam and West argued that Islamophobia pressures the Muslims

Promote True Image of Islam through media and academia

Islamophobia agenda widely spread through social media. Therefore, muslim scholars and research center should publish international journals, hold conferences and counter the orientalist stereotypes.

For instance, a book of Karen Armstrong "Muhammad: A Prophet of our Time" is the best counter narrative building step.
