1. INTRODUCTION:

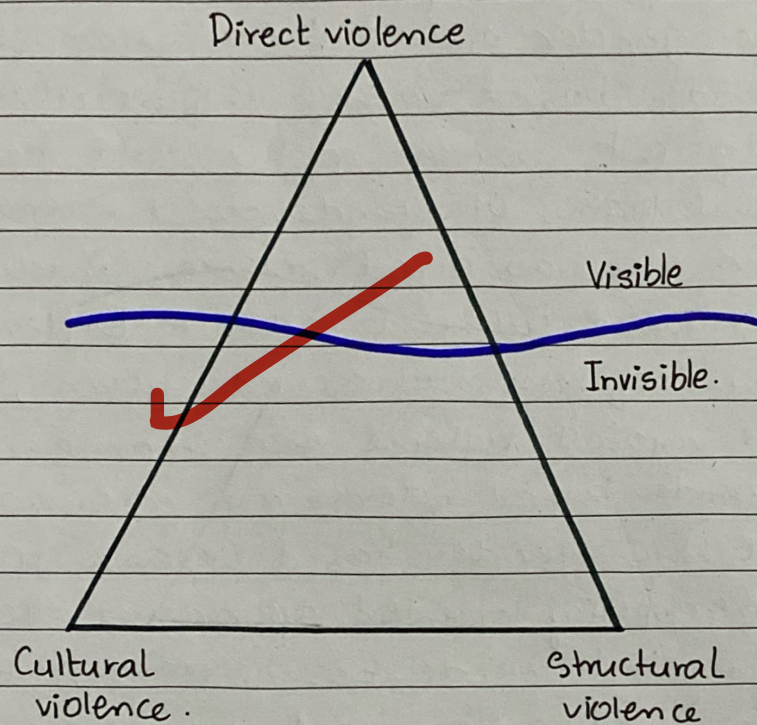

Gender Based violence is defined as,

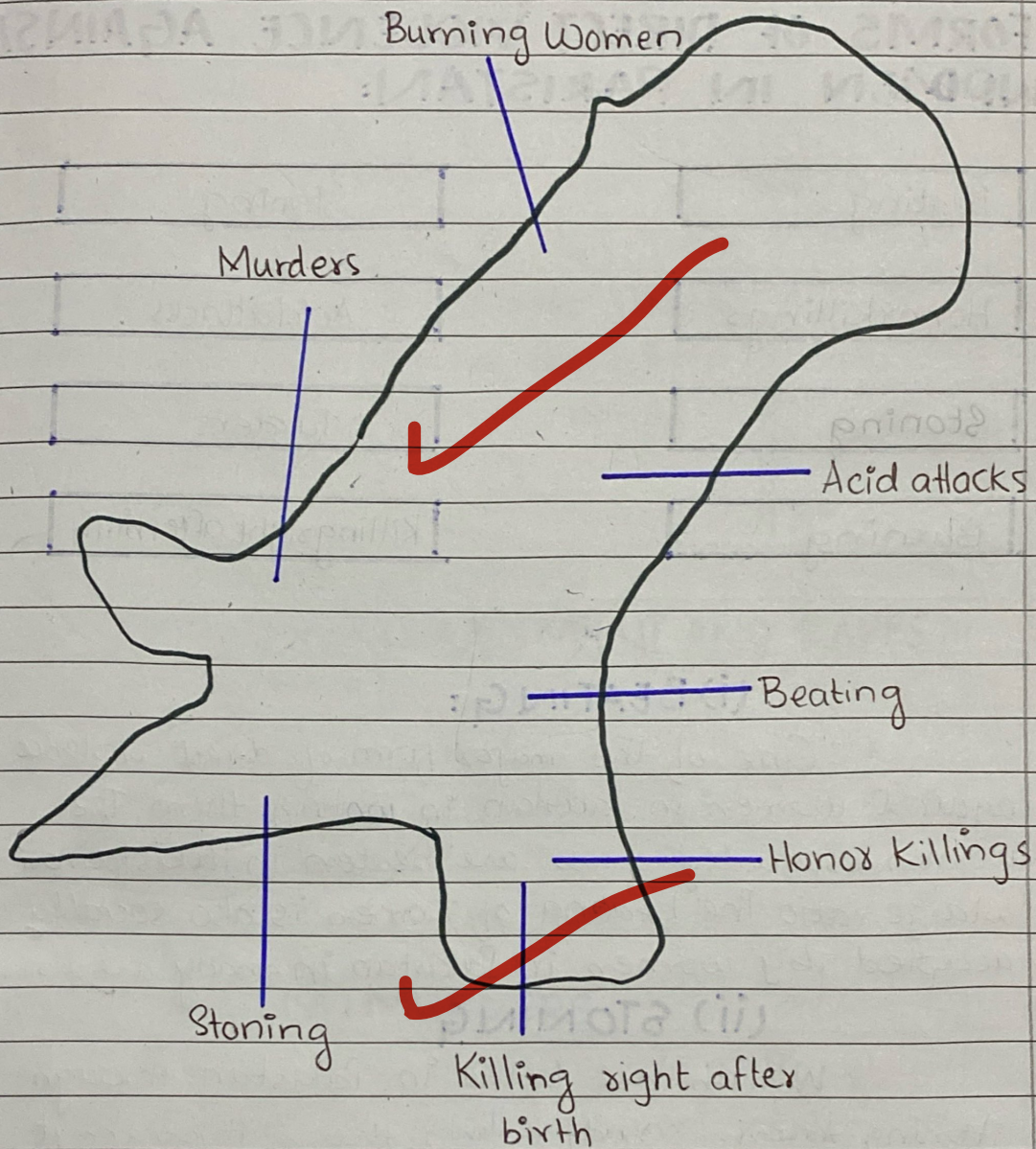
Violence against a particular gender in society considering the gender as weak and incompetent. Gender Based Violence is particularly done against women around the world.
