Introduction

Islam is a Comprehensive way of life that provides a Coherent framework for belief, conduct and social organization. "This book, there is no doubt in it, is guidance for the righteous."

As it provides moral, legal and social guidance.

Belief in Prophets

Belief in all prophets ensures continuity of divine guidance. Prophet Muhammad (S.A.W) is the final messenger. Muslims believe that all prophets conveyed the same core message of monotheism, morality and accountability.

"Muhammad is the messenger of Allah and the seal of the prophets."

Belief in the Day of Judgement

The belief in Akhirat asserts that life does not end with death. Every individual will be resurrected and held accountable for their deeds. Justice, often delayed or denied in this world, will be administered in the hereafter.

Belief in Divine Decree (Qadr)

Belief in Qadr affirms that Allah has ultimate knowledge and control over all affairs, while humans are granted free

within moral responsibility. This balance fosters, patience, resilience and accountability.

Doctrine of Akhirat (Hereafter) in Islam

The doctrine of Akhirat is the moral engine of Islamic life.

Concept of Accountability

Islam teaches that every action good or bad will be judged by Allah. Even minor deeds will be weighed.

"Every soul will be held in the Pledge to what it earned" (74:38)

Justice beyond the world

Akhirat ensures absolute justice. Oppression, exploitation and injustice that escape punishment in the world will be addressed in the Hereafter, offering hope to the oppressed & warnings to wrongdoers.

"And your God is not unjust to His servants".

Reward and Punishment

Belief in Paradise (Jannah) and Hell (Jahannam) motivates righteous conduct and deters immoral behavior.

Reform of Individual Life Through Islamic Belief

The Prophet (S.A.W) said;

"The wise person is the one who holds himself accountable and works for that which comes after death".

Moral Discipline and Self-accountability

Belief in Allah and Akhirat develops inner moral restraint. A Muslim restrains from wrongdoings not merely due to fear of law but due to consciousness of divine accountability.

This command established women's right to intellectual development and social participation

Economic & Property Rights

Islam granted women an independent economic and legal identity, recognizing their right to own, inherit and manage property. This provision empowered women economically and protected them from financial exploitation.

Right to Consent in Marriage.

Islam strictly requires the consent of women in marriage thereby rejected forced unions. The prophet declared;

"A woman cannot be married without her consent"

This safeguarded women's autonomy and dignity in marital matters.

Measures adopted to Maintain Women's Dignity

Safeguards Legal

Islamic law ensures women's protection through legally binding marriage contracts, mandatory dower (Mahr), inheritance rights and the right to seek divorce (Khula).

This measures institutionalize women's right and prevent abuse.

Moral & Social Protections

Islam promotes modesty, mutual respect and social ethics to protect women from exploitation. The Quran protect both genders;

"Tell the believing men and women to lower their gaze and guard their modesty."

Accountability and Justice

Islam assign men to the role protector and maintainer with responsibility rather than superiority.

"Men are protectors and maintainers of women".

This ensures justice, care and accountability within family structures.
