Distribution of topic should be according to the demand of the topic statement i.e. if there is one scoring point it should be given more weight, if there are 2 or more scoring points all should be given equal weight.

All claims made in the essay must be substantiated. Out of 15-17 arguments at least 9-10 should be academically backed with proper references. The rest should be backed by either case studies or generally known information.

1. Introduction

LANGUAGE (25%)

Focus on enhancing your writing skills as any essay with 4-5 grammatical mistakes does not pass.

Your essay must be in the tone and tense of the topic statements. Essays that fail to comply do not pass.

Your sentence structure should be simple, yet clear and diversified.

Vocabulary used should be simple, clear and concise. Expression should always be formal and academic.

You are never to write in 1st and 2nd person pronouns.

You must always use the given keywords and your topic for your thesis statements and main headings in your outline.

STRUCTURE (20%)

Your essay must follow the selected pattern and that structure should be maintained throughout.

INTRODUCTION: The introduction is the longest paragraph of the essay, at least 200 words. It should start with a hook, must give the glimpse of what's to come and must have a thesis statement. Besides hook your introduction should not have any sort of information and reference. Avoid definitions in introduction.

BODY PARAGRAPHS: Approximately 150 words at most and all the body paragraphs must be consistent in length. Should follow the proper structure of an academic paragraph i.e. it must have a topic sentence, supporting point, evidence and concluding sentence. The topic sentence and concluding sentence must align with each other. There should be no new information in the concluding sentence. One paragraph represents one subheading in the outline and consists of one idea.

CONCLUSION: Must start with the concluding phrase. There should be no new information in the conclusion. It should recap the arguments. Conclusion does not have any examples and information. If you are ending it on a hopeful note, remember that solutions and hope are not the same.

Essay:

A child's place is in a classroom, not a workplace. While others go to classroom, millions of children wake up to factories, fields, and streets. Child labour refers to the practice in which children are forced to work at an early age, often in unsafe and unhealthy conditions, instead of attending schools and getting education. It mainly affects children in developing countries where poverty, unemployment and lack of access to education forces families to employ children. It can be found in different sectors such as factories, agriculture, workshops, domestic sectors and street vending. Child labour has existed for centuries, especially during pre-industrial and industrial periods. In the early agricultural society, children used to work with their families in the fields. Whereas the problem got reversed during the industrial revolution, in which factories, mines, workshops employed large number of children as labors. They were preferred because they could be paid low wages and were easier to control. According to UNICEF and ILO, there are 138 million children engaged in child labor (2024), with 54 million working in dangerous conditions. Pakistan has one of the highest rates of child labor in South Asia, with around 6.8% of children engaged in child labor.

Child labor remains a neglected issue despite being a serious violation of children's rights. Although laws and agreements regarding child labors exist, the problem remains to be un-noticed in many parts of the world.

One major reason of the child labour is that it occurs in hidden sectors like home, private offices, farms, workshops etc. These areas or settings are hard to regulate because they are outside the formal labor inspection systems, that makes the happening invisible to authorities. The authorities such as agencies, police etc can't enter the private premises to look for the children employed as labours, leaving them unprotected from exploitation.

A second major reason is that the society accepts the practice of child labor as normal. This happens mostly in the poor communities and developing nations, partly due to socio-economic pressures. Families often consider it as pride and early-skill of the children, if the child works at early age. The child is considered as intellectual and responsible citizen if he or she does child labor at early age.

Poverty is the third major factor of child labour. This forces families to choose income over education and health. often families struggle to afford basic needs, they often rely on whatever additional

Since then nobody dared to ask what had happened because of the fear and of the owner. The owner got no punishment because of the corrupt system. Even where law exists, they often apply only to formal workplaces, leaving street-based or informal work child-labor outside legal framework.

Most of the people are unaware of the harms and legal limits associated with child labor. A lack of education and public campaign means communities do not

always recognize child labor as a serious rights violation. Without strong public awareness, even well-intended policies may remain ineffective. Thus the lack of awareness reduces the concern and action regarding the child labor.

The government attention and resources are often focused on other sectors or issues since the government itself is facing multiple socio-economic problems such as poverty, unemployment, health issues that may prioritise those issues over child labor.

Due to the limited budgets and resources, child labor receives insufficient funding and priority.

These are the factors due to which the child labor remains an ignored sector.

Now the here are the way forward, policy and reforms such as implementing strict laws, accessing to education and economic opportunities for families that can help eradicate child labor from the society.

In Brazil, there established a cash transfer

Program ~~that~~ named as "Brazil's Bolsa Familia Program", that reduced risk of child labor by linking financial aid to school attendance.

The second one is the "Ghana's Cocoa Industry Initiative" that was the collaboration between government, NGOs and companies to eliminate child labor in cocoa production.

Third one is the popular "Bangladesh's Garment Industry Reforms" that was the safety initiatives and strict regulations that reduced child labor from working in different garment factories.

In Conclusion, child labour remains a serious neglected issue and social problem worldwide.
