2. Markey and Shaw proposed Chicago project in order to cope up with crime rate in socially disorganized areas.


Markey and Shaw have proposed a project called as **Chicago Area project**. This project was proposed in order to cope up with the crime rates in socially disorganized areas-

3. Rising crime rates of urban areas in Pakistan:


The rate of crimes in urban areas have been increased due to several reasons such as:

2.3) Rehabilitation centers engage offenders in community based work:


The Rehabilitation centers engage offenders in the community based work such as those works in which they become busy and earn something by their own.

The Rehabilitation centers engage with the guardians of the offender in order to engage and provide information of the offender.


2.5) If the offender is less than eighteen year; they can be placed in observation homes:





1.2) There should be separate court for Juveniles, no joint trial of Juveniles:

According to Section 4 of the Juvenile Justice System act. There should be separate court be established for juveniles instead of joint trial of juveniles. Separate trials be taken

2.3) ~~Observation homes for juveniles be established:~~

The observation homes for juveniles be established by non-governmental organizations.

2.4) ~~Trial of juveniles should be completed in six months:~~

The trial of juveniles should be completed in six months.

2.5) ~~Privacy of juveniles should be maintained throughout the proceedings:~~

The privacy of juveniles should be maintained throughout the legal proceedings of the trial.


2.6) ~~Female juveniles should be investigated by female officers:~~

2.7) Juvenile may consult to defense attorney:

A juvenile has given the authority or right to consult and hire defense attorney.

The identity of the juvenile cannot be disclosed in any of the news channels or media or on social media. It cannot be kept public, as per juvenile justice system act of 2018.

Smuggling is considered as a crime. It can be money laundering, trans border smuggling, female smuggling, drugs smuggling etc.


2.1) Smuggling as Money laundering.
