Any sort of discrimination, violence, and oppression on bases of gender is called Gender Based violence. It varies from society to society and culture to culture. For instance in Europe being gay or man having feminine tendencies are less likely to be isolated by society; But in Pakistan such acts are taboos and highly criticised by social values. From killing of women on name of honour to discouraging female education and not owning intersex babies (XXY), Pakistani society practice GBV in every fields stretching from home to public spheres. To curtail GBV in Pakistan, the government needs to include politics in constitution regarding protecting ^{Transgender} ~~gender~~ and punishing parents for ~~dis~~ abandoning them. Women empowerment, strict legal actions, and inclusion of Gender Studies in school curriculum to spread awareness and tolerance in young minds.

GBV and various forms in Pakistan

Gendered based violence is the suppression of someone due to their biological sex and spread of inequality. The master-slave pattern in society on bases of identity. In Pakistan, the

violence on women, weaker masculine men, and intersex are example of GBV. The patriarchal hypernormative rule of Father dominates over all other genders. Men who are capable to portray all demands of Society e.g. aggression, masters, Empowered, and strong are praised on other hand of same XY-chromosome holder shows weaker, emotional, and nurturing tendencies they are labelled as incompetent and abused for not being manly enough.

In social Spheres of State all ^{Public} spaces are occupied by man and female all restricted to private Spheres is due to Gender based violence. The man are allowed to carry out every act of ~~crime~~ crime but if women tries to stand for their due rights they are objected to be characterless.

victim blaming has been a cultural norm in country and especially if case is related to rapes keeping the opportunities and Freedom for male, women are expected to remain in layers of dress codes, no night outs, no excess to market. If a female goes out from her house she is expected to be accompanied by a male member of family. These limitations on mobility is a type of GBV.

From honour killing to child marriage the young girls are doomed to have an opinion. GBV starts from the very place they ~~live~~ live as protection - home. From prenatal abortions to son preferences ~~then~~ Gendered - plays its role in giving respect and hate.

Lack of health facilities and malnutrition of female by families are proof of GBV. As per WHO, every 3 out of 5 women has iron deficiency and osteoporosis. This is mainly because gender decides one's worth in patriarchal societies.

Apart from these the concept of Vani, Samas and brides price for to resolve conflicts in parallel settings of jirgas and tribal settings are a type of GBV. An eye opening case of Murtiaram Mia, from a rural setting of Punjab questioned the alleged traditions of society. To justify killings or crimes by male, female are used as price to be paid. She was given by her own family to save their son and was tortured for the crime she never did. Seeking justice ~~over~~ name of gang rape by jirgas without constitutional legality are biggest contributors to GBV in Pakistan.

From clothing, food, health, education to responsibility of nurturing and reproduction, gender is used as a tool to divide and spread violence on weaker ones. When domestic violence remains personal and not political Pakistan's legal framework fails to protect its citizens and their fundamental rights.

Apart from women, gender based violence occurs in shape of abusing men for not showing masculinity. If men tries to be expressive and tries to help in domestic

Spouse they are also subject to abuse. From whistling to calling names since Ran Mureed even filed GBV for not fulfilling cultural demands and expectations.

Intersex are proven to every type of violence, from lacking identity, family, education and jobs economic means; they are treated as curse and non-living. Sexual abuse and no sense of belonging exclude them from fabric of society. They are most vulnerable as state does not provide them their basic rights. In history of Pakistan sex transpeople never became part of mainstream political representation. They got their protection from state in 2018 and acts for their violence are still not passed. These all violence are because of their gender.

Practical and Policy oriented strategies to overcome GBV in Pak

- (1) Legal Framework and Inclusivity of all type of human protection in constitution irrespective of their gender. From men to LGBTQ+, Freedom of life, liberty, and Property is everyone's rights and no state can snatch it from human. As J.S. Rousseau said in his book "Social Contract", "A state is responsible to provide fundamental, by birth rights of all citizens." Pakistan must pass Bills for empower women and providing job market to intersex.
- (2) Public-Private dichotomy and gendered division of labour must be discouraged.

and all type of domestic violence should be treated as crime against state. Personal must become political to safeguard women in their homes. As most of GBV cases occur inside boundaries of private sphere.

(3) STRICT laws and ~~heavy~~ ^{capital} Punishment on rapist and other sexual criminals to create deterrence in society. Cases of ~~honor~~ and ~~noor~~ ^{marhumam} must be set as precedent for future to curtail GBV.

(4) campaigns, Funds and programmes on Equality of all gender should be part of curriculum. Students must be taught their rights and gender neutrality. Courses like "Home Economic" which ~~best~~ promotes gender discrimination must be dropped or replaced with skill based labor to empower women.

(5) Family laws and laws of property ~~should~~ must get improvement and turned into practical reality for society by courts as done by Justice Iftikhar and Ayaz to safeguard financial independence of women.

Conclusion

In a nutshell, the violence varies from type and intensity but it remains illegal and liable. From psychological, emotional to physical violence on basis of gender has taken many lives in Pakistan. To overcome these criminalities; Rules, customs, and educational and institutional structures need to be changed. Pakistan needs more

Female and gender neutral political, economic and Policy making. From infrastructure to removal of ~~Parallel~~ justice systems Pakistan can overcome Gender Based Violence.
