Define Green house effect:

Green house effect is climate related phenomenon in which increasing concentration of green house gases like nitrogen oxides, carbon oxides particularly CO_2 , CH_4 and sulfur gas oxides that entrap the reflect waves from earth within environment causing increase in temperature.

Green house Gases:

- 1 Methane gas CH_4
- 1 Carbon dioxide CO_2
- 1 Nitrogen oxides NO , NO_2
- 1 Sulfur oxides
- 1 water vapours.

Elucidation of Phenomenon:

The phenomenon of GHE has been occurred in the atmosphere particularly in troposphere ranging from (1-18km) earth surface. There are numerous green house gases present in the troposphere

like CO_2 , CH_4 , NO_2 , SO_2 , water vapours. Now, there are two types of rays that come from the sun.

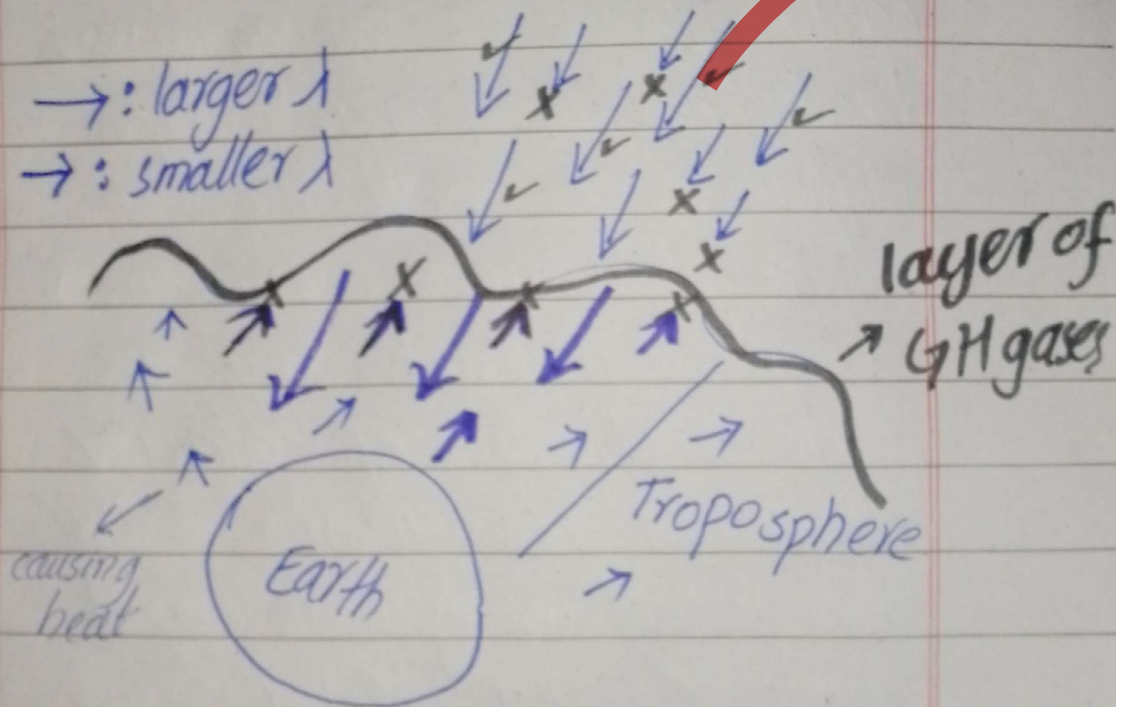
One type with longer wavelength and other with shorter or smaller wavelength. The

layer of green house gases permitted ~~longer~~ wavelength

waves while restricting ~~long~~ small wavelength based are prohibited.

Similarly, when these rays reached earth and ~~reflected~~ back their longer wavelength converted

smaller wavelength. But GH~~g~~gasses do not allow smaller wavelength based rays to escape. Therefore, these rays create heat in the troposphere. When there would be huge ~~am~~ amount of GH^ggases present then these would create more heat in the atmosphere. This phenomenon is called Green house effect.



Global Warming:

Due increase in green house gases, the temperature of the earth increasing day by day. This effect of GH gases is called Global warming.

2. Spinach is source of vitamin

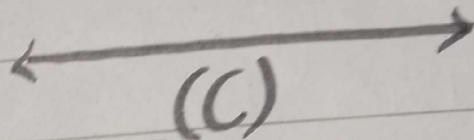
C. 1 Fish is source for vitamin B.

Explanation:

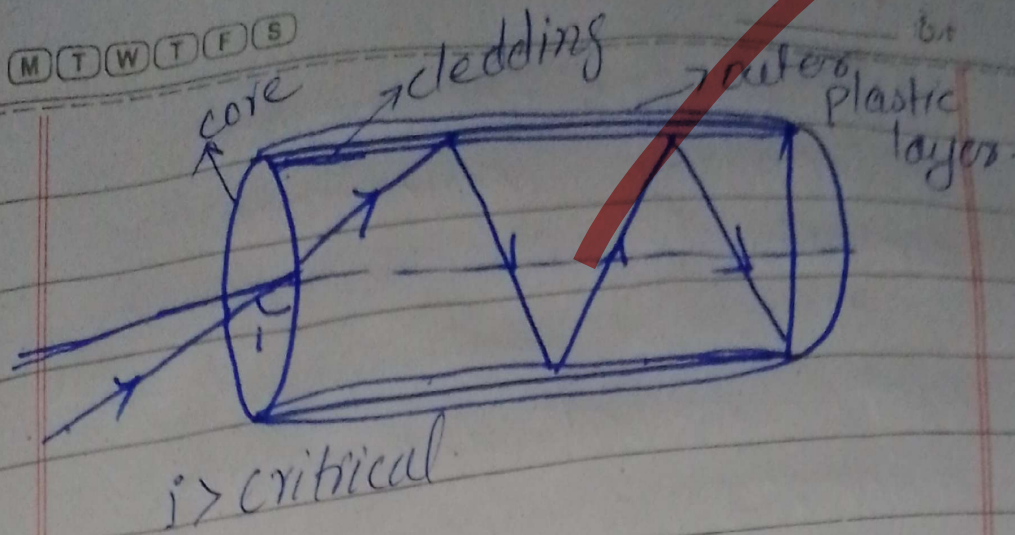
The light passes through core and entered in internal structure. The refractive index of cladding is ~~less~~ than core. This helps to propagate total internal reflection.

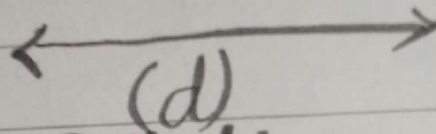
Speed: The light passes with very high speed of $500,000 \text{ km/sec}$.

Pakistan is facing severe consequences of climate change due to global warming. Here is the list of those effects which Asia-e-Pakistan is currently facing

- 1) Intense increase in temperature & severe heat waves in summer
- 2) Rapid melting of glaciers
- 3) Recurring severe floods.

- 4) Increase in landslides in hilly areas
- 5) Severe droughts in Sindh: 22% of area got barren.
