


# Question No 1

Therefore in In The World Economic Forum (WEF) 2023 Global Gender Gap Report, Pakistan ranked last (148th out of 148 countries) with a 56.7% gender parity score, a decline from the previous years indicates the gender discrimination in larger scale. This gender discrimination open doors for gender based violence, honor killing, economic disparities for women and several more hurdles from a female child to adult, even old. Women are not safe in Pakistan. ## 2.3) Keeping them Busy Learning Skills and Activities


