2. Strengthened Partnership with China

4. Regional Diplomatic Balancing

Challenges of Foreign Policy

1. Over Dependence on Major Powers

- Policy reversal due to reliance on US Aid
- Reduced Strategic Autonomy.

2. Strained Relation with India

- Kashmir Crisis Post 2019
- Diplomatic deadlock and regional instability strained and increased tension in relations with India

3. Afghan Policy Blow back

- Enhanced refugee burden
 - Cross border militancy
- Resulted in trust deficit with Kabul: that ultimately a site of tension to have such relation with border sharing country

4. Weak Economic Diplomacy

All these factors along with limited export growth and poor global economic integration more adversely impacted already weak economic diplomacy of Pakistan

Major - Non traditional Security Threats

1. Terrorism and Extremism

- Ideological difference across the cross border and domestic difference

2. Economic Insecurity

- Debt burden due to unstrained pressure of circular debt in almost all government financial.
- Inflation and unemployment high and increasing rates
- It should be addressed through structural reforms not by force.

3. Climate Change

- Uncontrolled and unpredictable climate change resulting in floods and droughts and water scarcity.
- Requires a structured governance policies and international cooperation

4. Cyber and Information Warfare

Due to comparatively lack of awareness high illiteracy rate and least upto date education curriculum pace with fake news and disinformation campaigns that are easily spreadable. To overcome this needs digital literacy and cyber capacity.

5. Population Explosion

Uncontrolled increasing population result in pressure on resources health and education that need long term social planning to cope with this problem.

Diversity in Ground of Non-Traditional Security Threats

Non-traditional security threats in Pakistan fundamentally differ from conventional threats because they originate from multiple non-military grounds, each requiring distinct policy.

Socio-Ideological Ground

Extremism, radicalism and sectarianism from ideological grounds, weak education system and social polarization. These threats cannot be neutralized through force alone; require counter-narrative, educational reform and social inclusion.

Economic and Structural Ground

Economic insecurities arise from unemployment, inflation, debt dependency and governance failure. This

demand for institutional reforms, economic diplomacy and sustainable development rather than coercive measure.

Environmental and Resource Based

Climate change, Water scarcity and floods are non-human induced threats that transcend borders. This management depends on climate governance, disaster preparedness and regional cooperation not deterrence.

Challenges in Addressing These Threats

- Absence of human Security Paradigm
- Institutional fragmentation
- Policy inconsistency and reactive governance
